# Walk Against Hunger

## About the Walk

- The Connecticut Foodshare **Walk Against Hunger** is the largest anti-hunger event of its kind in Connecticut.
- Connecticut Foodshare invites qualified partner organizations to participate in the **Walk Against Hunger** as Benefitting Partners, where they can use the **Walk** to raise funds for their local food assistance program.





## Important Information

- This year the **Walk Against Hunger** is on **Saturday, April 25, 2026**, at Dunkin Park in Hartford, home of the Yard Goats.
- Check-in will begin at **8 AM**, and the 1.5-mile **walk kicks off at 10 AM**.





## Agency Partner Eligibility

- To participate and fundraise as a Benefitting Partner, an organization **must** be a current Connecticut Foodshare agency partner in good standing and operating a food pantry, backpack program, community kitchen and/or emergency shelter.

- To be considered for this opportunity, please review and submit the electronic application no later than **Friday, February 20, 2026, by 11:59 PM**.

# Walk Against Hunger

## Agency Partner Eligibility

- Reminders will be sent in the **January & February 2026 newsletters**.
- Once submitted, your application will be reviewed by Connecticut Foodshare staff for eligibility, and you will be notified if your organization has been accepted as a Benefitting Partner.
- If your application is not received by the noted due date of **Friday, February 20, 2026, at 11:59 PM**, you will be ineligible to participate.

# Walk Against Hunger

## Benefits of Participation

- Connecticut Foodshare takes on the cost of running this large-scale fundraising event with an easy-to-use online donation platform called Classy, and Benefitting Partners can create a custom online **Walk Against Hunger** fundraising page to share with their supporters.
- As with last year, Benefiting partners will keep **100% of funds** raised by walkers who select your organization upon registering. And, also like last year, Connecticut Foodshare will cover any credit card processing fees and fees associated with the online fundraising platform; equal to roughly **6% of every donation** received.





# Connecticut Foodshare Walk Against Hunger

## Fundraising

- Last year, **57 Benefitting Partners** raised **\$190,000** to benefit their local programming.
- While in-person attendance is encouraged, Benefitting Partners are not required to attend the **Walk** in-person to participate in this online fundraiser. If you attend in person, you have the option of hosting an informational table at the **Walk** so attendees can learn more about your organization.

# Walk Against Hunger

## Funding Timeline

- Shortly after the Walk, the preliminary fundraising results designated to your organization will be e-mailed to the contact listed in your Walk Against Hunger application.
- Benefitting Partners have until **noon Friday, May 8, 2026**, to submit additional funds collected. Only money received on [www.ctfoodsharewalk.org](http://www.ctfoodsharewalk.org) or at Connecticut Foodshare's Wallingford or Bridgeport facilities by this date will be counted in your organization's fundraising totals. We are unable to make exceptions for funds received after this date.

# Walk Against Hunger

## Bonuses

- In addition to the funds designated to your organization, there is an opportunity to earn bonuses!
  - \$500 bonus to the **first-time Benefitting Partner** that raises the most funds
  - \$500 to the **returning Benefitting Partner** with the largest percentage increase in fundraising over 2025
- Bonuses will be calculated using Walk fundraising results as of **May 8, 2026**, close of business. Any bonuses earned will be included in the final check mailed by Connecticut Foodshare in **June 2026**.
