Our Mission

Revitalization Unlimited invests in historic properties and industrial manufacturing businesses nationwide. Strategically utilizing federal, state, and local tax benefits to reduce risk and enhance equity investment profitability results in benefits for both investors and local communities.

Investment Objectives

1. Generate income from real estate and manufacturing businesses
2. Preserve and grow capital through curated asset acquisition
3. Optimize tax benefits, such as historical preservation incentives



◆ Our Real Estate Investment Strategy

We acquire historic properties with significant development rights, assess their potential, and prioritize preservation with a historic preservation easement (HPE). This structure affords investors a non-cash charitable tax deduction, thereby augmenting returns and mitigating risk through our comprehensive knowledge of and strict adherence to relevant regulations.

We then focus on stabilizing and optimizing the property's cash flow, which may involve redevelopment of the building's interior. This process can attract Federal and State tax incentives that cover 40% or more of the redevelopment costs.

✦ Historic Preservation Easement (HPE)

An **HPE** is a binding legal agreement tied to a property deed that permanently protects a historic property's character, features, and setting for the future, despite changes in ownership. Donating an HPE creates a charitable deduction as defined in IRC §170(h).

To value the charitable donation, a conservation easement is appraised by determining the property's "Highest and Best Use," creating a hypothetical project plan, and then performing a "Qualified Appraisal" to value the unbuilt structure.

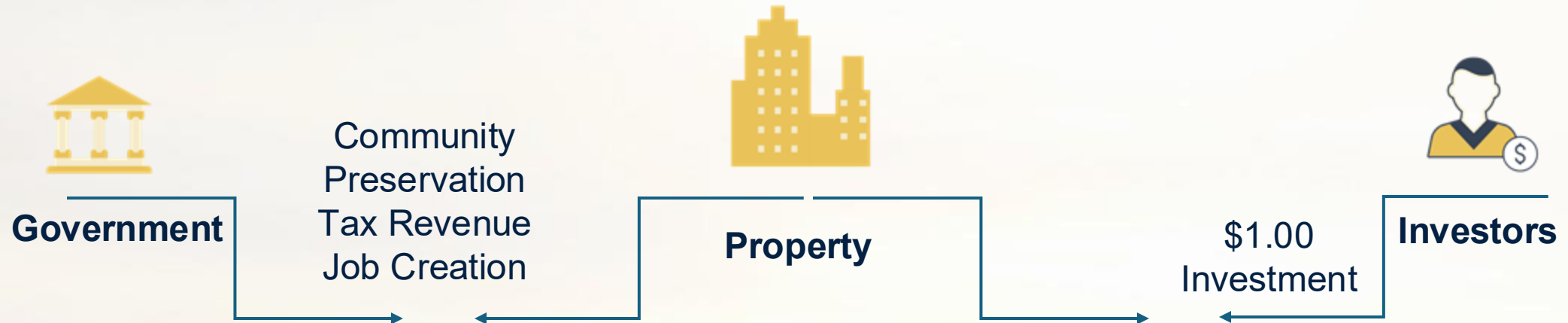

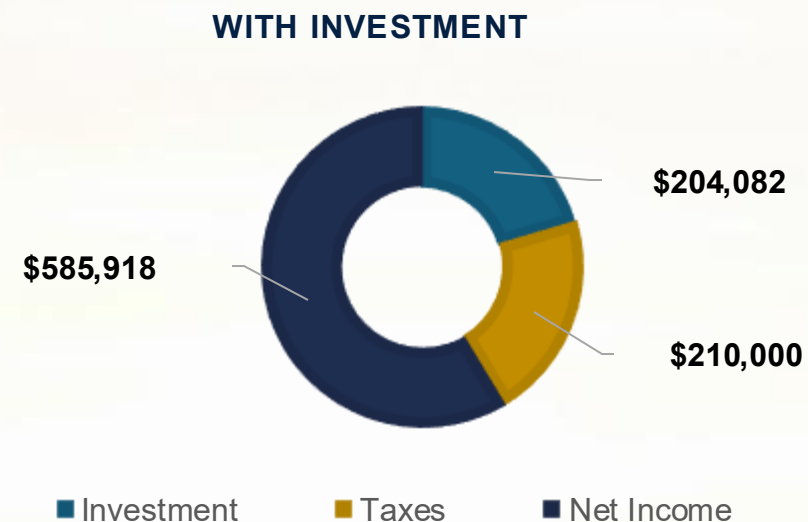
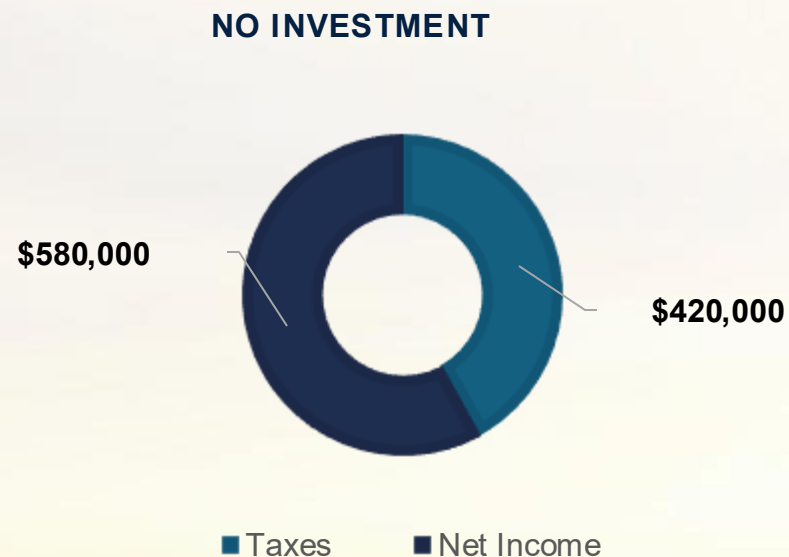
