Lakeland REA is in the process of rebranding so please watch for our new look and logo in the coming weeks.

The Alberta Government Electricity Rebate

The Alberta Government announced an electricity rebate to be delivered to eligible Alberta electricity customers. Lakeland REA will ensure the rebate is delivered to eligible Lakeland REA members as per the approved Government of Alberta legislation.

- ⇒ Eligible customers include residential farm, irrigation and commercial electricity sites consuming less that 250 megawatt hours per year in 2022.
- ⇒ Beginning in the July billing cycle, eligible members will see the rebate automatically appear on the Lakeland REA bill on the front page as "GOA Utility Commodity Rebate".
- ⇒ The rebate will be automatically applied to bills and will be distributed as a \$50 monthly rebate for each eligible site for six consecutive months for a total of \$300

Members do not need to do anything to receive the rebate, and there is no application process of the rebate. For more information on the Government of Alberta Rebate, please visit: https://www.alberta.ca/affordability-programs.aspx

Board of Director Nomination Notification

At the 2022 LREA Annual General Meeting, there will be three Board of Director positions up for election. The Board positions are:



Derwent (Zone 2) for a 3-year term Martins (Zone 5) for a 3-year term Director at Large #2 for a 3-year term.



Members in good standing will be considered for approval by the Nomination Committee.

Nomination Process

As described in the by-law, nominations for the office of Director must be submitted to the Secretary of the Association in the 45-day period between July 15th and September 1st of the year in question.

Nominations will not be accepted after September 1.

A nomination for Director must have the signature of the candidate certifying that he/she is a "member in good standing" and eligible for election. The members making the nomination must be from the same zone as the nominee and must also sign the nomination form indicating that he/she is also a "member in good standing".

Nomination forms will be available at the Lakeland REA Ltd. office on July 1st of each year and will also include a package of information regarding the duties and obligations of a Board member. This package of information will include the Lakeland REA Business Plan, Strategic Plan, Rural Utilities Act and Regulation, a copy of the latest independent audit and a copy of the Board Self-Governance Policy for Code of Conduct & Confidentiality Agreement.
