At the 2025 Lakeland Power Co-op Annual General Meeting, there will be four Board of Director positions up for election. The Board positions are:



Barich (Zone 1) for a 1-Year Term
Derwent (Zone 2) for a 3-Year Term
Martins (Zone 5) for 3-Year Term
Director at Large #2 for a 3-Year Term



Board of Director Nomination Notification

As described in the by-law, nominations for the office of Director must be submitted to the Secretary of the Association in the 45-day period between July 15th and September 1st of the year in question.

Nominations will not be accepted after September 1st.

A nomination for Director must have the signature of the candidate certifying that he/she is a "member in good standing" and eligible for election. The member making the nomination must be from the same zone as the nominee and must also sign the nomination form indicating that he/she is also a "member in good standing".

Nomination forms will be available at the Lakeland Power Co-op office on July 1st of each year and will also include a package of information regarding the duties and obligations of a Director. This package of information will include the LREA Mission and Vision Statements, Business Plan, Strategic Plan, Rural Utilities Act and Regulation, appropriate Common Law, a copy of the latest independent audit, a copy of the Board Self-Governance Policy for Code of Conduct & Confidentiality Agreement and associated attachments.
