The Board of Darke County Commissioners, acting as the contracting authority, and the Village of Arcanum, acting as the owner, will receive sealed bids for the construction of the First, East, Albright & South Street Reconstruction project located within the Village of Arcanum, Ohio.

Bids will be received at the offices of the Board of Darke County Commissioners located at 520 South Broadway Street, Greenville, OH 45331, until 1:00 p.m. (local time), April 2, 2024. Bids will be opened at 1:30 (local time) and publicly and read aloud. Bids received after 1:00 p.m. (local time) will be returned unopened. Bids shall be marked, "First, East, Albright & South Street Reconstruction Project" and include the Bidder's name and address. Sealed Bids **must** contain an original and **two** copies of the Bid submission.

Bids will be received on a unit price basis as outlined in the bid documents:

The project consists of the reconstruction of First, East, Albright and South Street. Included are waterline, storm sewer, curb and gutter, sidewalk, and street improvements.

Bids must be signed and submitted on the separate bidding forms included in the Bidding Documents, sealed in the provided envelope, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier's check in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. Bid security, furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. The successful Bidder will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid.

All contractors and sub-contractors involved with the project will, to the extent practicable, use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Attention of bidders is called to all of the requirements contained in this bid packet, particularly to the Federal Davis-Bacon prevailing wage rates, encouragement of Disadvantaged Business Enterprises (DBE) utilization, various insurance requirements, various equal employment opportunity provisions, and Section 3 Requirements.
