The Union County Commissioners will receive sealed bids for the construction of the Magnetic Springs Sanitary Sewer System project.

Bids will be received at the Union County Commissioners office located at 233 West 6th. Street, Marysville, Ohio 43040, until 9:30 a.m. (local time), October 8, 2025, at which time and place bids will be opened publicly and read aloud. Bids received after 9:30 a.m. (local time) will be returned unopened.

Bids will be received on a unit costs basis as outlined in the bid documents. The total cost estimate for the project is \$5,800,000.

The project involves the construction of a new central sewer system for the Village of Magnetic Springs. It will include the construction approximately 9,000 feet of 8-inch gravity sewer, 28,800 feet of 6-inch force main sewer, lift station and other miscellaneous construction items.

Bids must be signed and submitted on the separate bidding forms included in the Bidding Documents, sealed in the provided envelope, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. Bid security, furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. The successful Bidder will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid.

Attention of bidders is called to all of the requirements contained in this bid packet, particularly to the federal Davis-Bacon prevailing wage rates, federal Section 3 requirements, Build America Buy America (BABA) provisions, encouragement of Disadvantaged Business Enterprises (DBE) utilization, Ohio EPA requirements, various insurance requirements, and various equal employment opportunity provisions.
