The Village of St. Henry will receive sealed bids for the construction of the Transmission Line for Wells PW-11 & PW-12 project.

Bids will be received at the Council Chambers of the Village of St. Henry, 121 W. Washington Street, St. Henry, OH 45883, until 10:00 a.m. (local time), October 2, 2025, at which time and place bids will be opened publicly and read aloud. Bids received after 10:00 a.m. (local time) will be returned unopened.

Bids will be received on a unit price basis as outlined in the bid documents.

The project involves the installation of approximately 15,800 LF of 8" waterline to transport water from wells #11 & #12. The project is located along Burrville Road and S.R. 119 and extends east to Township Line Road.

Bids must be signed and submitted on the separate bidding forms included in the Bidding Documents, sealed in the provided envelope, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. Bid security, furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. The successful Bidder will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid.

Attention of bidders is called to all of the requirements contained in this bid packet, particularly to the federal Davis-Bacon prevailing wage rates, encouragement of Disadvantaged Business Enterprises (DBE) utilization, Ohio EPA requirements, various insurance requirements, and various equal employment opportunity provisions. This procurement is subject to the EPA policy of encouraging the participation of small business in rural areas (SBRAs).
