Forwarding Remains to Out of Town Funeral Home \$3500

Our fee for this service includes: basic services of Funeral Director and Staff; transfer of the deceased to funeral home within 25 mile radius; procurement of signed death certificate at the time of initial transfer; basic embalming; Obtaining Out of State Burial Transit Permit and shipping container. This fee does not include: shipping charges; casket; services or ceremonies; foreign shipment of remains; or any other services not specifically listed.

Receiving Remains from Out of Town Funeral Home \$3000

**These charges are only applicable when the decedent is received in a casket and all arrangements have been scheduled through an out of town funeral home.** Our fee for this service includes: basic services of Funeral Director and Staff; transfer of the deceased to funeral home within 25 mile radius; use of Hearse to cemetery and graveside service. This fee does not include: merchandise, dressing, cosmetology, visitation, funeral ceremony or airline fee.

Immediate Burial \$20950 - \$3300

Our fee for this service includes: basic services of Funeral Director and Staff; transfer of the deceased to funeral home within 25 mile radius; shrouding or dressing; casketing; identification; shelter of remains and transfer to the cemetery via hearse to local cemetery and graveside service. All cemetery fees and other third party fees must be paid directly by the responsible party prior to the time of burial. ***Embalming or refrigeration will be needed after 24 hours.***

Direct Cremation \$3200 - \$2700

Our fee for a direct cremation, without any services or ceremonies, includes: basic services of Funeral Director and Staff; initial transfer of decedent within 25 mile radius; procurement of signed death certificate at the time of initial transfer; preparation for identification; identification, cremation fee and a temporary container for the cremated remains (not an urn). *If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of corrugated cardboard and wood.*

However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.*

**Basic Services of Funeral Director and Staff** **\$2600**

Our fee for the basic services of the Funeral Director and Staff includes, but is not limited to: 24-hour availability of staff to respond to initial request for service; shelter of remains; staff to respond to subsequent inquiries; arrangement conference with family and/or responsible parties; reverent care of remains; procurement of certificate of death at time of removal; recording of vital statistics; preparation and filing of necessary certificates and permits; preparation and placement of classified death notices; coordination of requested services with cemetery, crematory, vault companies and/or others; preparation and dissemination of service information to inquiring parties; accounting; bookkeeping; clerical and administrative costs; compliance with state and federal regulations; insurance; taxes; professional licens-ing; and aftercare. *This fee for our basic services and overhead will be added to the total cost of the funeral arrange-ments you select. (This fee is already included in our charges for direct cremations, immediate burials, and forward-ing or receiving remains.)*

**Embalming** **\$700**

We require embalming when non-cremated remains are present at a public viewing. In order to effectively protect our community from any potential hazard, it is our policy to embalm remains that have been in our custody for 24 hours. This policy applies only when a decision regarding the final disposition has not been communicated to the funeral home within 24 hours. *Except in certain special cases, embalming is not required by law. Embalming may be neces-sary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalm-ing, you usually have the right to choose an arrangement that does not require you to embalm, such as direct crema-tion or immediate burial.*

**Use of Facilities, Staff and Equipment for Services and Ceremonies**

**Visitation at the Funeral Home or Another Facility** **\$500**

Our fee for this service includes: arrangement of visitation room; use of visitation room and requested items; place-ment of casketed remains; receiving and displaying floral arrangements; supervision and attendance prior to and after the visitation; and on-call staff during visitation hours. This fee does not include fees for the use of the other facility that may be charged or flower transportation.

**After hours visitation at another facility** **\$300**

Any services outside of the funeral home after 4:00 p.m. requiring funeral staff such as transportation to or from the facility or presence of the funeral staff to supervise services.

**Funeral Ceremony at the Funeral Home or Another Facility** **\$500**

Our fee for this service includes: supervision and attendance of a Director and other personnel before, during, and after the ceremony; funeral set-up; flower set-up; use of the facility and equipment; clergy records; and personnel to assist in the closing of the casket. This fee does not include fees for the use of the other facility that may be charged or flower transportation.

**After hours funeral ceremony at another facility** **\$300**

Any services outside of the funeral home after 4:00 p.m. requiring funeral staff such as transportation to or from the facility or presence of the funeral staff to supervise services.

**Committal or Graveside Service** **\$300**

Our fee for this service includes a licensed Director to supervise pallbearers and arrange and lead the funeral proces-sion. This charge does not include transportation of flowers or a vehicle to transport the deceased.

**Memorial Service at the Funeral Home or Another Facility** **\$600**

**This service is designed for families choosing direct cremation through our facility.** This service is inclusive of the following without the deceased present: your family will be provided with personnel to coordinate services, clergy records, personnel to assist with the funeral; facility’s equipment; and artful display of flowers. This fee does not include transporta-tion of large equipment or flowers.

**Memorial Service at the Funeral Home From Another Funeral Home** **\$1400**

**This service is designed for families choosing direct cremation not through our funeral home.** Our fee for this service without the decedent present includes: supervision and attendance by personnel before, during, and after the service; music, memorial facility’s equipment; and distribution of flowers within the facility.

**Reception/Repast Room Rental** **\$100**

This fee includes the use of our reception/repast room only.
