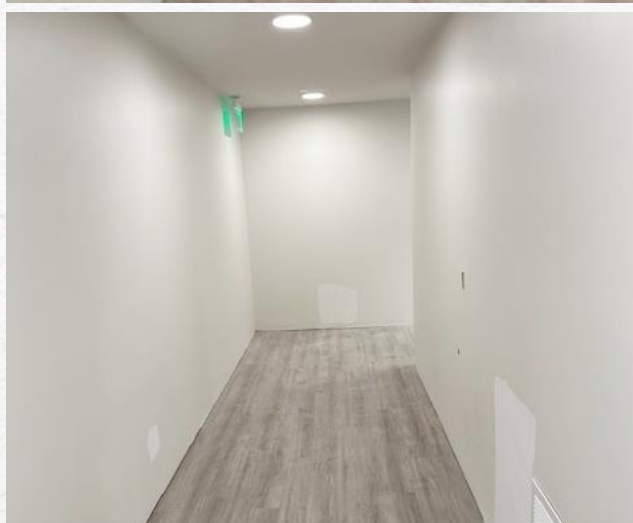

Vicinity Map

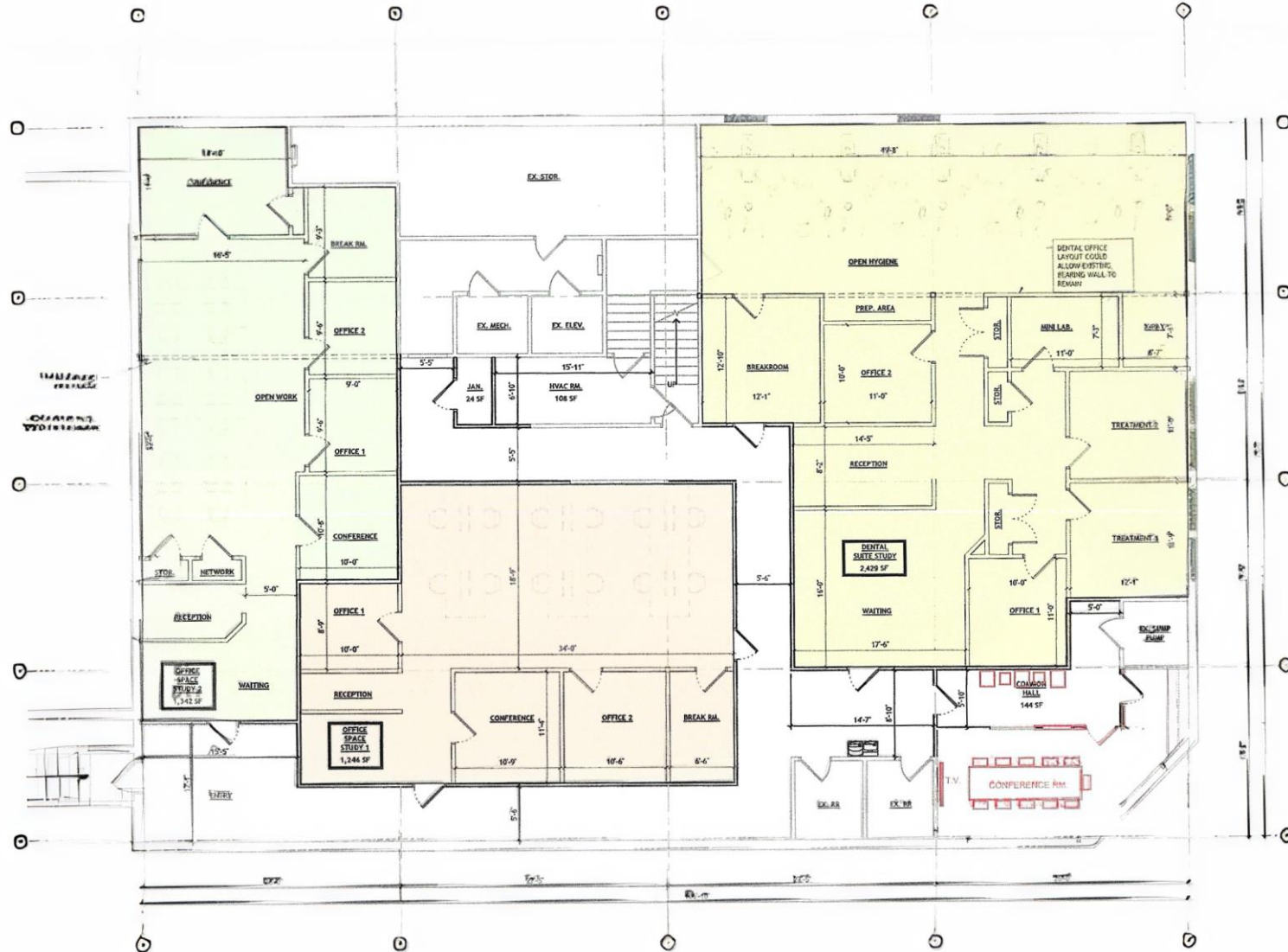


Property Layout
