**FINANCIAL:** There is an entry fee of **\$20** for up to 3 entries due on or before receiving. The fee is non-refundable. You may pay online at: <https://www.sancapart.org/activities-events> (scroll down to the “Paradise” exhibit) with a credit card or you can pay in-person at Receiving with CASH OR CHECK ONLY. All work must be available for purchase. Sale transaction is handled solely between artist and buyer. A donation of **10%** of the purchase price, (per item sold), payable to the Sanibel Public Library is appreciated. Artwork that is sold may be removed with the prior approval of the Chairpersons. In such instances the artist will be asked to replace the work with another piece of suitable art if possible.

**ACCEPTED MEDIA:** Oil, acrylic, watercolor, gouache, pastels, pen & ink, pencil, charcoal, fiber, collage, pastel, mixed media, pen and ink, etc. NO PHOTOGRAPHY or AI generated work.

All artwork must be original to the contributing artist. Copyright infringement of any kind is unacceptable. Artwork may not have been executed under instruction of another, copied from publications or the work of another artist.

**FRAMING AND WIRING:** The library cannot display 3D art. Artwork size is restricted to no greater than 24” in any direction. Unframed canvas must be finished on all sides...no visible staples. Framed artwork must have clean, sturdy frames with no loose parts or glass. Wire must be 3 inches from the top of the frame and wires must be taped for protection. No string, gallery clips or saw tooth hangers. The library has a hanging system, and proper framing is essential for the hanging system. Paintings must be thoroughly dry. Affix the labels available on the SCAL website to the back of each piece.

## Artist Agreement/Release

**NOTE:** At Receiving you must supply this signed “**Artist Agreement/Release**”, payment of **\$20** for up to 3 entries, an **Artist Statement/Biography** (Artists should submit a single page biography/artist statement for inclusion in a Gallery binder during the exhibit), **SCAL labels completely filled out for each entry**, and **proof of membership to SCAL**. Entry and acceptance of artwork is conditioned on artist’s acceptance of all terms herein as well as artist’s or agent’s signature or mark to this agreement.
