- 2. Artist agrees to provide original 2D artwork.
- 3. Submissions are limited to 1 piece of artwork, space dependent.
- 4. No photography accepted.
- 5. The artist agrees that the artwork will be properly wired for hanging or properly secured for standing. Plexiglass should be used on any work over 16" x 20". 2D artwork has a size limit of 122 inches or less in perimeter, including frame.
- 6. The artwork and the exhibit will be representative of the theme "*Wild*" and align with the mission statement of SCCF, which is to protect and care for Southwest Florida's coastal ecosystems.
- 7. The artist will be responsible for transporting artwork to the exhibit.
- 8. The artist agrees to label his/her piece clearly with title, selling price and medium.
- 9. For each work on display during the duration of the exhibit, the artist is responsible for each sale and is subject to a 20% donation to SCCF, if sold.
- 10. Please provide a one-page artist's biography or artist's statement for inclusion in a gallery binder on the receiving date.
- 11. Artist gives SCCF permission to use photographs of artwork on exhibit or provided by artist for publicity purposes.
- 12. No artwork may be removed prior to closing of the exhibit, unless approved by Jenny Evans (SCCF), or Brooke Simon or Maureen Ginipro (SCAL).
- 13. The artist shall sign up for at least two docent sittings during the exhibit.
- 14. SCCF & SCAL will exercise care with respect to the property exhibited as it does in safeguarding its own property, but SCCF & SCAL does not accept responsibility for the loss or damage to the

artist's work while on exhibit. The artist hereby agrees to release and hold SCCF, SCAL and its agents (including staff and volunteers) harmless from any liability for damage resulting from loss or damage to the artist's
