Make or update your will and living will

- Name / designate a guardian for your children
- Name / designate a guardian for your pets
- Name an executor to carry out the terms of your will and estate
- Create a list of your personal property & assets
- Designate who would receive your assets & property
- Consult with an attorney to consider creating a Trust

Designate durable powers of attorney

- Designate a financial power of attorney to make financial and other business decisions and arrangements on your behalf
- Ensure your power of attorney can access your accounts if you are unable to, and provide copies of your power of attorney paperwork to your financial institution(s)
- Designate a medical power of attorney to make medical decisions on your behalf
- Determine and document your advanced health care directives and your medical care preferences
- Ensure your medical care providers know your preferences, and provide them with copies of your directives and medical power of attorney documents
- Gather, list and secure your insurance documents, financial documents, and other important documents.
 - 401(k), IRA, Retirement Accounts, Financial accounts & institutions, Credit Cards, Loans; identify all debts, obligations and liabilities
 - Life, Healthcare, Property, etc., Insurance documents
 - Car Titles, Property Deeds, Social Security card, Birth / Marriage certificates
 - Memberships & Organizations you are a part of
 - Military Discharge Documents
 - Name / Review your beneficiaries to policies as needed
 - Where will your documents be stored?
