This privacy policy applies only to our collection of information; it does not apply to information that you may provide to or is collected by a third-party site or platform, including those that link to us or that we link to. Any information that is provided to or collected by a third-party site or platform is subject to that third-party's privacy practices and policies, including any privacy rights that the third-party may offer.

We follow this privacy policy in accordance with the applicable law of the United States and those of its states in which we operate. We do not operate in countries other than the United States and we do not knowingly offer or provide our services to residents of countries other than those of the United States.

By using any of Red State's Services you are agreeing and consenting to the terms of this Policy. It applies to all of the information we collect from you, regardless of how we collect it.

II. INFORMATION PRACTICES AND POLICIES

1. How We Collect Your Personal Information

We collect information from you through our website and over the phone in order to provide you with more information about our services and to manage our relationship with you. We also collect information from you when you apply to use our Services as a customer and to manage our relationship with you as a customer. You will voluntarily provide most of this information directly to us.

We use cookies, pixels, and tags on our website and certain marketing emails, which collect your IP address and certain other information from you when you visit our website, including when you visit our website via a link on another website. For further details, please see our Cookie Policy Section, below.

We also collect information using analytics tools, including when you visit our website.

The specific information we collect and how we use that information are discussed in more detail below.

2. What Information Do We Collect and When?

Information You Provide To Us. Certain information we collect is provided by you voluntarily in using our Services.

When you create an account with us, we collect the information as part of the application process, which **may** include:

- your name;
- the username that you create;
- your email address;
- your physical address;
- your phone number;
- social security number;
- payment information (e.g., credit card information); and
- financial institution information (e.g., existing retirement account number, bank account number, routing number).

When you create an online account with us, we will also require you to create a password. You can help protect your personally identifiable information by using a combination of letters, numbers, and characters in your password, changing your password often, using a secure web browser, and signing off our Website when you are finished with its use. We also encourage you to choose a password that is unique to our Website and not recycle your password for another site or company.

When you inquire about our services, we collect the following information:

- your name; and
- your contact information, which may be your email address, your phone number, or both.

When you visit our Website, we also collect the following information:

- the date and time that you access the Services.
- your internet service provider, mobile carrier, or data services provider,
- · your IP address,
- the pages you visit,
- the features used.
- information about the task you performed,
- any information or product that you give us in performing the task,
- how you arrived at the Services

We may also collect information from social media platforms and networks that you use in connection with our website or mobile application. For more information about social media platform and network privacy practices, please review the privacy policies and settings of the social media platforms and networks that you use.

Emails. When you send emails to us, we retain emails in order to process your request, respond to your inquiry, and improve our Services. If you report a problem with our Services, there may be additional details requested.

Google Analytics. We have implemented certain Google Analytics Advertising Features. Google Analytics helps us analyze a user's behavior on our Website and what online channels they used to find

the Website. We then can create audiences based on users' behavior on the Website to send them relevant advertising.

We do not currently permit third parties to direct ads to you on our sites and applications, but third parties may do so on other sites to which we publish content. You may choose not to receive or control targeted advertising from many ad networks and partners, data exchanges, and marketing analytics and other digital advertising and marketing service providers. 3. How Do We Use Your Personal Information?

In general, we use personal and aggregated information collected through the Website to fulfill your requests for services, contact you, customize content, and improve the design and performance of the Website. More specifically, consistent with applicable law and choices and controls that may be available to you, we may use information collected from you, or from devices associated with you, to:

- to provide you with services, including responding to your inquiries and fulfilling your requests;
- to communicate with you generally about our services and services that we might provide, including products or services for which you apply or may be interested in applying for, or to provide you with updates or information concerning our services in which you are already enrolled, changes to terms, conditions, and policies and/or other administrative information.

- to allow you to apply for products or services and evaluate your eligibility for such products or services;

- for business purposes, including data analysis, audits, developing and improving products and services, enhancing the Website, identifying usage trends, and determining the effectiveness of promotional campaigns;
- to enforce this Privacy Policy;

- to fulfill our legal obligations to you; and
- as we believe to be necessary or appropriate: (a) under applicable law, including laws outside your country of residence; (b) to protect our operations; (c) to protect our rights, privacy, safety or property, or that which belongs to you or others; or (d) to allow us to pursue available remedies or limit the damages that we may sustain.

4. Do We Share Your Personal Information?

We do not sell information that identifies you personally.

We also do not share information that identifies you personally with third parties other than as follows:

Service Providers. We may share personal information with third parties who service your accounts and provide services on our behalf.

Marketing Purposes. We may share your name, email address, physical address, phone number, and purchase information with service providers who we use to offer our products and services to you; to affiliated partners to market their products and services to you; to nonaffiliated partners to market their products and services to you; and for joint marketing with other companies.

Protection of Red State and Others. We may access, monitor, use or disclose your personal information or communications to do things such as (a) comply with the law or respond to lawful requests or legal process; (b) protect the rights or property of us, our agents, our members, our customers, and others including to enforce our agreements, policies and terms of use; and (c) to respond to emergencies.

By using the Website, you consent to us providing your information to third parties as detailed above.

5. How Long Do We Retain Your Personal Information?

In general, we keep your personal information for the duration of your relationship with us. Once you terminate your relationship with us, we generally will continue to store archived copies of your personal information for legitimate business purposes and to comply with the law.

Your information will remain subject to the terms of this Policy even if we undergo a business transition. We may transfer your information to a successor person or entity upon an acquisition or other corporate reorganization. You hereby consent to such transfers, and we may assign and transfer all of the rights, benefits, duties, and obligations of this Policy.

Please note that we will continue to store anonymous or anonymized information, such as website visits, without identifiers, in order to improve our Services.

III. YOUR CHOICES

Consistent with the rights afforded to California residents by the California Consumer Privacy Act (CCPA), we afford certain rights to you regarding your personal information. Your rights include:

- You may request to Red State the categories and specific pieces of personal information that we have collected about you;
- You may request that we correct or update the personal information we have collected about you;
- You may request that we delete certain personal information that we have collected about you;
- You may request a list of those to whom we have disclosed your personal information;
- You may opt out of receiving future marketing materials and emails;
- You may opt out of disclosures of your personal information to third parties under certain circumstances;
 and
- Not be discriminated against as a result of exercising any of the aforementioned rights.

We make good faith efforts to provide you with access to your personal information and the ability to correct the information if it is inaccurate. We may decline to process requests that we believe in good faith are unreasonable or unduly burdensome (such as requests that are repetitive, require disproportionate technical effort, jeopardize the privacy of others, or would be impractical to satisfy).

2. Deleting Your Account and Personal Information. If you end your relationship with us, you can request that we delete your personal information by contacting us as discussed above. When your information is deleted, we will do so consistent with any applicable legal requirements. Why do we use cookies? We use cookies to collect information whether users are clicking on links or engaging with us. The cookie information may include the date and time that you clicked on a link. How Long Do We Retain Your Personal Information?

We will keep the personal information we collect about you for as long as necessary to carry out the purposes set forth in this Privacy Notice or any other notice provided at the time of data collection, but no longer than as required or permitted under applicable law or internal Red State policy. We dispose of the information we collect in accordance with Red State's retention policies and procedures.

What Are Your California Privacy Rights?

If you are a California resident, you can make certain requests regarding your personal information, and we will fulfill each request to the extent required by law. If we are unable to comply with your request in whole or in part, we will notify you with reasons for the denial.

As stated in more detail below, you can request that we:

- Provide you with access to a copy of and certain details regarding the personal information we have about you.
- Delete your personal information.
- Stop selling your personal information or sharing your personal information for cross-context behavioral advertising.
- Correct your inaccurate personal information.
- Limit the use or disclosure of your sensitive personal information (SPI).

Request to Access My Personal Information

Requests to access your personal information may be submitted up to two times in a rolling twelve-month period. In response, we will return to you the following categories of information, to the extent required by law:

- The categories of personal information we have collected about you.
- The categories of sources from which we collect your personal information.
- The business or commercial purpose for collecting, selling, or sharing your personal information.
- The categories of third parties to whom we disclose personal information.
- The specific pieces of personal information we have collected about you.
- A list of categories of personal information that we have sold or shared for cross-context behavioral advertising, along with the categories of third parties we sold it to or shared it with for cross-context behavioral advertising.
- A list of categories of personal information that we have disclosed for a business purpose, along with the categories of third parties we disclosed it to.

Delete My Personal Information

You have the right to ask that we delete your personal information. Once we receive a request, we will delete the personal information (to the extent required by law) we hold about you as of the date of your request from our records and direct our service providers to do the same. Choosing to delete your personal information may impact your ability to use our websites and online features, including closure of your online account, and limit your use of in-store functions that require your personal information. Stop Selling or Sharing My Personal Information

You have the right to opt-out of the sale of your personal information or sharing of your personal information for cross-context behavioral advertising. Your opt-out request may be processed differently depending on whether you are logged into your account. If you are logged in, your preference will be associated with your account, and the device on which you exercised your choice. When you log in from another device or browser, it too will be automatically opted out. If you are not logged into your account, your request will only be associated with that one browser. We also support your use of the Global Privacy Control (GPC). If you notify us of your privacy preferences through GPC, we will honor your request with respect to the browser or device that sends us the GPC signal, and when you login to your account from that device, the opt-out will extend to your account, as well.

If you change your preference from opt-in to opt-out, you may be asked to confirm your preference prior to it taking effect. After opting out of the sale of your personal information or sharing of your personal information for cross-context behavioral advertising, you may still receive ads from Red State, however they will not be tailored to you.

Correct My Personal Information

You have the right to ask that we correct the personal information we may have collected about you if that information is inaccurate. We reserve the right to request identifying documentation from you in certain circumstances, as permitted by law. Limit the Use and Disclosure of SPI

You have the right to ask that we limit our use and disclosure of your SPI to certain purposes permitted by law. We will not discriminate against you for exercising your rights. We will not deny you goods or services, charge different prices or rates, provide a different level of service or quality of goods, or suggest that you might receive a different price or level of quality for goods. Some programs or membership services require usage of personal information to function, so compliance with your request may impact those experiences.

How Do We Verify Your Identity to Complete Your Access, Correction and Deletion Requests

If you request access to, or the correction or deletion of, your personal information we will verify your identity before disclosing the requested information. To do so, we may ask that you log into your account or provide us with your:

- First name*, middle initial, last name*
- Address*
- Email address
- Phone number

*Required field

When you make a request, you will be asked to answer a few questions about yourself to help us verify your identity. Third-party identification services may help us with verification to prevent disclosure of your personal information resulting from fraudulent requests. You may be asked to log into your online account and complete a one-time passcode validation. In the event more documentation is necessary to verify your identity, we will notify you directly.

What If You Can't Verify My Identity?

If we can't verify your identity, we will notify you, and your request(s) to access, request, or delete your personal information may not be processed. Any requests may be denied if we have reason to believe they are fraudulent.

How Do I Submit a Request Using an Authorized Agent?

If you'd like an authorized agent to exercise your rights for you, they may use the same email and street addresses described above to submit requests. We require documentation demonstrating your agent's authority to submit requests on your behalf. For example, a valid power of attorney or other documentation, including a letter, signed by you (the California resident) authorizing the agent to submit your requests.

Shine the Light

California residents also have the right to request that we provide you with (a) a list of certain categories of personal information we have disclosed to third parties for their direct marketing purposes during the immediately preceding calendar year and (b) the identity of those third parties.
