How to apply:

We accept electronic applications only. Send your application in PDF format (failing that, make it .doc/.docx or .odt), as an attachment to application@amazingflamingo.it

Application fee:

- The **15€** application fee is not-refundable and have to be paid in advance to processed your application. Payments should be made through www.PayPal.com to application@amazingflamingo.it from the same email address used to send in your application (if that is not possible, please note clearly both in your application and in your payment that you are using different name).
- Make sure you note your legal name as well as your performer name in the payment.
- IMPORTANT NOTICE: Please do not forget to include the PayPal receipt for your payment in your application e-mail!

Commitment:

- If you are selected to perform at the festival you have to confirm within 3 days by e-mail sending your mp3 music in attachment (please rename your music as yourstagenameact1.mp3), 2 web resolution photo (1 close-up, 1 full-length) and 1 high resolution photo (minimum 300dpi)
- If you need to credit the photographer please add the name of the photographer to the photo you submit. If you do not have permission to use a photo please do not submit.
- If for any reason you cannot commit to your confirmation of attendance to the Festival please let us know asap, if you fail to do so your application will not be considered in the future editions of the CBTF.
- You cannot perform in similar events until 15 days prior to the commencement of CBTF or 14 days after in the Piemonte region. We understand that performers need to work, but we also know that you can understand our point of view. All of type of shows and events, big or small scale, are included in this restriction.
- All correspondence between the performer and CBTF including this agreement is confidential and must not be discussed with a third party before, during or after the festival.

Please contact the artist manager for further information if clarification is required. Breach of this term may result in immediate cancellation from the CBTF.

Application categories:

Specify if you want to perform on:

- "La Madamina - Monsu Contest" to be held on both Friday, October 9 and Saturday, October 10 (1 time contest - 2 time flamingo gala)
- "Flamingo Gala Show" (category dedicated to "Best Performers") to be held on Friday, October 9 that on Saturday, October 10 (1 time contest and election Madam or Monsu - 2 time flamingo gala)

Expenses/Payment and Invoices:

Please note that the CBTF does not cover any of your expenses regarding the festival (travel expenses, hotels or meal allowances)

Only if you are selected to perform to Flamingo Gala you will receive a fix fee: Italian performers will receive 150€, and international performers 200€, for act.

If you are a group, you will get paid the same as a solo performer, that means we pay for act and not for person.

In order to make the payment, you must be able to invoice the fee to CBTF

Nudity: full nudity is NOT permitted.

Fire: Fire is not permitted at the Event in the Theatre

Areal: Areal act are not permitted in the festival venues.

No act changes: you have to perform the act we select through the video attached. Please write a note if your act is changed in some part.

Routine: All routines must be max. 5 minutes or less

Footage:

Your application must include a link to footage of the act you wish to perform. There are no exceptions to this rule. The quality of the film/lighting/background etc. is not of great concern, what we need is to see your routine properly. Please note that all material must be made publicly available on-line and that we won't log in anywhere, join any sites or download any material.

Artist Passes/Complimentary Tickets:

- ALL performers will be allowed to attend shows where they will not perform
- No complimentary family or friends tickets are offered

Communication:

- Correspondence will be sent via whatsapp. We strongly recommend that you provide your phone number to include you in the group to avoid delays in the delivery of information. This group is for informational purposes only.
- For personal questions or concerns regarding invoices, applications, etc., please send an e-mail to application@amazingflamingo.it

Photography/Videography:

- Please be advised that CBTF will be photographed and possibly videotaped. By submitting your application and accepting the 'Terms and Conditions' you are agreeing to allow CBTF to use your images for ongoing promotional usage. CBTF is very mindful of using any photos or footage in a professional and appropriate manner. We are aware of being sensitive to posting 'partial nude shots'.
- The performer will allow any footage and photography from the CBTF to be used for future promotion and marketing of the festival.

Venues and Technical Information:

- Technical information regarding the stage, lighting, access to the venue, dressing room etc. will be emailed closer to the time .
- Lighting requests are taken into consideration but are at the discretion of CBTF
- A follow spot, haze machine, UV lighting, projectors etc. are not always available at the venues and CBTF does not hire extra equipment for individual artists. If you require extra equipment you must discuss with the team immediately on confirmation. We will inform performers of what is available.
- CBTF will provide a Stage Assistants during the show. No personal assistants/helpers are permitted under any circumstances unless approval has been given.

Rehearsals, Formats, Acts:

Tech runs and/or rehearsals will be available at the venue on the day of the events. Rehearsal times will be strict and subject to change. Late arrival to tech runs may mean you forfeit your spot. Formats and rehearsal sheets will be sent seven days prior to the commencement of the festival.
