

## INFORMATION YOU WILL NEED WHEN YOU CALL

When you speak with Land of Lincoln, we will first determine if you are eligible for services. You will be asked the following questions:

- What kind of problem do you have?
- Where do you live?
- What is your name?
- Who do you have a legal problem with?
- How many people live with you?
- How much is your household income?
- How much money do you have on hand or in the bank?

## NEXT STEPS

If your call is handled by the Legal Advice & Referral Center, you will speak to an attorney over the telephone about your problem immediately. If you qualify for more than advice, the attorney will refer your case to a regional office for review.

If your call is handled by a regional office, you will usually be called back or sent a letter for an in-office or telephone appointment.

## IF WE CANNOT ACCEPT YOUR CASE

We cannot accept every case. If we cannot help you with a legal problem, we will refer you to the Illinois State Bar Association referral service at (217) 525-5297 for the name of an attorney who can help you for a fee.

## WHAT IS LAND OF LINCOLN?

Land of Lincoln Legal Aid is a 501(c)(3) non-profit organization that provides low-income and senior residents of central and southern Illinois with free high quality legal services in order to obtain and maintain their basic human needs.

We believe all people of central and southern Illinois should have access to justice, income security, adequate housing, quality education, healthcare, safety from violence and exploitation, and the opportunity to improve their own lives.

## WHAT TYPES OF SERVICES DO WE PROVIDE?

The kind of help we provide ranges from telephone advice to representation in court or at administrative hearings.

The type of service we provide depends on the legal problem, facts of the specific case, and staff availability.

We handle civil cases only and do not help with criminal cases. More detailed information about our services can be found on our website, [www.lincolnlegal.org](http://www.lincolnlegal.org).

## WHAT TYPES OF CASES DO WE HANDLE?

Our attorneys may be able to help you with civil legal issues including:

- **Family Safety & Stability:** orders of protection, divorce, custody, guardianship
- **Housing:** eviction, unsafe living conditions, foreclosure
- **Elder Law & Disability Rights:** elder abuse and exploitation, advance directives, wills
- **Consumer Protection:** debt collection, bankruptcy, consumer fraud, identity theft
- **Health & Income Security:** Medicaid, Medicare, TANF, SNAP, Social Security
- **Education Law:** education issues for disabled children, discipline, suspension and termination from school, other education rights
- **Expungement & Sealing of Criminal Records**

**We do not handle criminal, traffic, personal injury, or probate cases.**

We also cannot handle cases where we have a conflict of interest. A conflict of interest happens when representing one person affects our representation of another person who is or has been our client.



## WHO IS ELIGIBLE FOR OUR SERVICES?

- Must be a U.S. Citizen or one of certain eligible non-citizens
- Must live in our service area or have a legal problem in our service area (see counties listed on other side of this brochure)
- Generally, must be income and asset eligible, unless authorized under other grants, such as seniors or victims of domestic violence

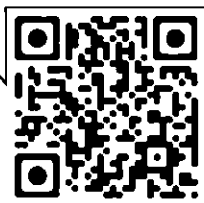
