* Tuition rates are assessed on a per child basis with no discount offered for multiple children attending from the same family.

IMPORTANT: Students are not considered enrolled for the 2026-2027 school year until a registration form is completed online and the registration fee has been paid. Your student must not have any outstanding balances on lunch, after care or past tuition. Holy Family does not currently offer any discounted tuition rates.

Payment Options: We strongly encourage you to sign up for FACTS Monthly payments. FACTS is a tuition company that sets up automatic payments from a credit card, checking or savings account on an agreed upon payment schedule for 10 months. Payment is withdrawn on the 5th or 20th of each month beginning in September. 2026-2027 Financial Aid

Indiana School Choice Scholarship: Families must meet all eligibility guidelines. Families will need to apply yearly. Families must be able to provide proof of household income and household size. The most common document used is the 1040 form from your Federal Taxes. This year the form is for the 2025 tax year. Families submit a copy of their tax return directly to the Parish Business Office or submit it online through FACTS. In order to submit them through FACTS you will need to fill out a FACTS Grant and Aid Application. Please note that the availability of the Indiana School Choice Scholarship is dependent on any legislative changes made by the State of Indiana. **After June 30, 2026 the income requirement will be removed. Families are now required to provide proof of Indiana Residency.**

Indiana residency can be verified by providing one of the following:

Bank statements, credit card bills, loan statements, lease agreements, mortgage, rental contract, property deed, tax bills, voter registration, USPS change of address confirmation, homeowner's, renters, auto, health insurance policies/cards.

The Financial Aid options listed below require a 2026-2027 FACTS Grant & Aid application to be filled out online. Please apply online at www.factsmgt.com and go to Financial Grant and Aid to fully fill out the application. Partial applications cannot be considered. All FACTS Grant & Aid applications must be submitted by 8-1-2026 in order to apply for the 1st semester.

Parish Financial Assistance: Families that are in need are asked to submit a FACTS Grant and Aid application prior to 8-1-2026. Again, the Indiana School Choice Scholarship will take precedence over Parish Financial Assistance.

Scholarship Granting Organization (SGO): Families must meet eligibility guidelines. **FACTS Grant & Aid applications must be submitted prior to applying for the SGO or 8-1-2026, whichever date comes first.** SGO has three application rounds per year, but children are limited to one scholarship per year.

Large Family Fund: This needs based grant is for parish families with three or more children in a Catholic school grades K-12. **Families are required to fill out the 2026-2027 FACTS Grant and Aid application prior to August 1, 2026.** FACTS analyzes the applications and submits recommended families to the Diocese Large Family fund committee.
