

# NEW FOREST 10 MILES EVENT TERMS & CONDITIONS

## UKA Full Licence ID: 2023-45130 (under UKA Rules)

I am a Participant and acknowledge that by participating in the New Forest 10 - 29th October 2023, I agree to the terms below and the Conditions, which include details of my cancellation rights. I also understand that I am entering in to a contract with the New Forest Runners and not UK Athletics Limited.

Under UK Athletic rules the use of MP3 players and similar devices are not permitted whilst running the course due to health and safety concerns

I hereby: agree that any participation by me in the Event is solely and entirely at my own risk and (to the extent permitted by law) no person(s) or organisation(s) shall be liable for any accident, harm, injury, loss or damage to property, however so caused, arising out of or in connection with or, suffered during or as a result of, my participation in the Event, provided always that nothing shall exclude liability for death or personal injury caused directly by the negligence of the organiser or its employees;  
consent to medical assistance and/or medical care being given to me in the case of illness, injury or an emergency situation, should this occur during the Event, such assistance to be given by the organiser, its employees, contractors or other trained personnel conducting the Event (which may include the use of anaesthetics);

Acknowledge and agree that:

1. Running is an endurance sport;
2. I should only undertake such an activity to a level which reflects my level of fitness;
3. I am responsible for monitoring my own physical condition prior to and during participation in the Event;
4. I understand the importance, for safety reasons, of obeying the rules, guidelines and instructions given by the Event Organisers officials, stewards, nominated representatives and other authorised personnel and hereby agree to abide by the same and to behave responsibly at all times during the Event and be mindful of the impact of my actions on others;
5. I agree that my participation in the Event is for recreational and/or charity fundraising purposes only and I will not participate in the Event for any commercial or business purpose. The Event organiser will have no liability to the Participant for any loss of profit, loss of business, business interruption, or other loss of business opportunity;
6. I agree that there may be photographers at the Event and that my image may be used for marketing and promotional purposes;  
and
7. I understand that entry fees are not refundable.

You agree that we may publish your Personal Information as part of the results of the Event and may pass such information to the governing body or any affiliated organisation for the purposes of insurance, licences or for publishing results either for the Event alone or combined with or compared to other Events. Results may include (but not be limited to) names, club affiliation, race times and age category.

We will not be responsible for any loss, theft or damage of your personal belongings, other than caused as a result of our negligence or other breach of statutory duty.

An entrant shall be deemed to have made himself/herself/their self, familiar with, and agreed to be bound by the UKA Anti-Doping Rules and to submit to the authority of UK Anti-Doping in the application and enforcement of the Anti-Doping Rules.

The UKA Anti-Doping Rules apply to entrants participating in the sport of Athletics, for 12 months from the date of entry, whether or not the licence holder is a citizen of, or resident in, the UK.
