### POSITION SUMMARY

Prepare and perform operations to product such as setting inserts, hand polishing, inspecting product to print requirements, detailing work-pieces as required. Prepare and package finished products for shipment as required. Monitor products on a continuous basis to ensure products are of prescribed quality and meet both Customer and Company expectations, requirements and standards.

### ESSENTIAL FUNCTIONS

- ◆ Follow established work procedures, and perform work assignments as required to meet all Starrett, Tru-Stone safety, quality and production goals.
- ◆ Study blueprints, work orders, and instructions to determine product specifications and requirements.
- ◆ Lift and position work-pieces, manually or with hoists, and secure them on tables or stands. Operate or tend tools that remove material on work-pieces.
- ◆ Measure work-pieces and progress of work, using measuring devices.
- ◆ Assist in the inspection and measurement of work-pieces to determine conformance to specifications.
- ◆ Set inserts in work-pieces using best practices to ensure quality requirements are met.
- ◆ Hand polish surfaces or components as required to meet specifications.
- ◆ Assist in performing operations using manual equipment to maintain production requirements of the area.
- ◆ Assist in preparing and packaging finished product as required to meet delivery schedule.
- ◆ Maintain current knowledge of the quality controls and stay current on literature and procedures pertaining to the area as provided by Unit Manager.
- ◆ Maintain a safe, clean and organized working environment.
- ◆ Maintain all tools and inspection equipment per established procedures and requirements.
- ◆ Supports Operational Excellence and other continuous process improvement programs as needed.
