## **INFORMATION ABOUT COVID-19**

COVID-19 is an illness caused by a virus that can spread from person to person. Recent studies have suggested that COVID-19 may be spread by people who are not showing symptoms. COVID-19 symptoms can range from mild (or no symptoms) to severe illness. Symptoms may appear 2-14 days after exposure to the virus and may include, among other symptoms, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, and diarrhea.

COVID-19 is a new disease and there is limited information regarding risk factors for severe disease. Based on currently available information and clinical expertise, those at higher risk for severe illness or death are people who are 65 years or older or people of any age with underlying medical conditions (such as chronic lung disease, moderate to severe asthma, serious heart conditions, severe obesity, diabetes, chronic kidney or liver disease, or those who are immunocompromised).

There is currently no vaccine to prevent COVID-19. The best way to prevent illness is to avoid being exposed to the virus that causes COVID-19. The Centers for Disease Control (CDC) currently advises that individuals stay home as much as possible and avoid close contact with others; wear a cloth face covering in public settings that covers the nose and mouth; clean and disinfect frequently touched surfaces; and wash hands often with soap and water for at least 20 seconds, or use an alcohol-based hand sanitizer. Although The Children's Tree Montessori School has put protocols and preventative measures in place, it remains possible for a student attending The Children's Tree Montessori School to become infected with COVID-19 or to infect others, even if a student is asymptomatic. Students living in households with individuals who are 65 years of age and older and/or have higher risk for severe illness from COVID-19 (such as people with underlying medical conditions) are recommended to stay home.

Because of its highly contagious and sometimes "hidden" nature, I understand that it is currently very difficult to control the spread of COVID-19 or to determine whether, where, or how a specific individual may have been exposed to the disease.

I further understand that The Children's Tree Montessori School is closely monitoring this situation and has put in place reasonable preventative measures aimed at reducing the spread of COVID-19. I recognize that the health and safety risks posed by COVID-19 cannot be completely eliminated, despite the implementation of reasonable and age-appropriate precautions and protocols. I also understand and acknowledge that given the unknown nature of COVID-19, it is not possible to fully list each and every individual risk of contracting COVID-19 and that neither The Children's Tree Montessori School, nor public health officials can guarantee that any student participating in on-campus programming at the School will not come into contact with someone with COVID-19 and/or contract such illness.

By enrolling my child in The Children's Tree Montessori School and/or by allowing my child to participate in on-campus programming at the School, I expressly acknowledge the risks associated with COVID-19 and agree to abide by such reasonable health and safety protocols that the School may implement during the 2020-2021 school year, which may include such measures as requiring students and parents to wear masks, engage in social distancing and regular handwashing, avoid the sharing of belongings and participate in screenings, testing and other measures reasonably designed to protect the health and safety of the School community. I understand that this is a shared responsibility and that every member of the School community must do their part to minimize risks.

## Assumption of Risks and Waiver of Liability/Release of All Claims

[Student], ASSUME ALL RISKS pertaining to the COVID-19 pandemic, inherent and otherwise, whether or not described above, in connection with the Student's enrollment and/or participation in on-campus programming at The Children's Tree Montessori School (School), and DISCHARGE the School its officers, trustees, faculty, employees, agents or other representatives under the direction and control of the School (the "Released Parties") from any and all liability, damage, injury or loss, including bodily injury or death, arising from, related to, occurring during, or associated with COVID-19 and the Student's enrollment and/or participation in on-campus programming at the School. These agreements of Assumption of Risks and Waiver of Liability/Release of All Claims do NOT apply if (1) the liability, damage, loss or injury is CAUSED SOLELY BY THE NEGLIGENCE of the Released Parties and do not include the negligence or any other act or omission by any other person or entity (such as the Student, the Parents, other third parties or independent vendors/contractors); or (2) the liability, damage, loss or injury is

CAUSED BY THE RECKLESS, WANTON or INTENTIONAL MISCONDUCT of a Released Party. These agreements of Assumption of Risks and Waiver of Liability/Release of All Claims will be construed in accordance with Connecticut law.
