1. Basic Services of Funeral Director, Staff and Overhead \$2,150

This charge includes consultation with the family or responsible party, personnel to respond to the initial request for service 24/7/365, arrangement of services, coordinating service plans with clergy, vault companies, cemetery, crematory and/or other parties involved in the final disposition of the deceased, recording vital statistics, preparation and place of obituary notice, securing official documents and necessary registrations and sheltering of the deceased.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. [This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.]

2. Embalming

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

6. Forwarding of remains to another Funeral Home \$2,595

Our charge includes basic services of funeral director and staff, embalming, transfer of remains to a funeral home within 50 miles (\$2.75 per mile beyond 50 miles). It does not include use of facilities and staff for visitation and/or funeral ceremony, any merchandise, or transportation to an airport and airfare.

7. **Receiving remains from another Funeral Home** **\$1,910**

Our charge includes basic service of funeral director and staff, temporary shelter of remains and transportation of remains to cemetery or crematory. It does not include any merchandise selected, services or ceremonies at our chapel or another facility, or transportation to an airport and airfare.

8. **Immediate Burial** **\$2,935 - \$11,830**

Our charge for an immediate burial (without any ceremony) includes basic services of funeral director and staff; transfer of remains to funeral home (within 50-mile radius; \$2.75 per mile beyond); and transportation to cemetery.

9. **Direct Cremation** **\$2,995 - \$7,890**

*This charge does NOT include Medical Examiner's fee.

Our charge for a direct cremation (without ceremony) includes basic services of funeral director and staff; transfer of remains to funeral home (within 50-mile radius; \$2.75 per mile beyond) basic preparation of unembalmed remains and cremation.

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are traditional wood caskets, cremation only caskets, or cardboard cremation containers.
