Enrollment Term & Payment

Enrollment is based on a **12-month contract** for all programs.

Auto payment or online payment is required. No other forms of payment are accepted.

School hours are **7:30 AM – 4:30 PM.**

Application & Enrollment

New families must submit an **online application** to be considered for enrollment.

Upon acceptance, families will receive an invoice for a **\$200 non-refundable application fee** and the required deposit.

A child's space is reserved once the **application fee and deposit** are received.

The **annual materials fee** will be invoiced and **due by July 1st.**

Probationary Period

All newly enrolled students begin with a **14-day probationary period.**

This period allows the school to observe the child's adjustment and ensure the program is an appropriate and supportive fit for the child and the classroom community. If concerns arise indicating that additional developmental or behavioral support may be beneficial, families will be notified and may be asked to seek guidance from the child's pediatrician or appropriate professionals within **30 days.** If it is determined that the school is unable to adequately meet the child's needs, withdrawal may be recommended by the school or initiated by the family. In these cases, **all fees will be prorated and refunded,** including those typically designated as non-refundable.

Withdrawals & Probation

The school reserves the right to require withdrawal if a student's academic, social, or emotional needs cannot be reasonably met. In cases involving serious incidents, a student may be placed on a **30-day probation** or required to withdraw immediately. A **30-day written notice** is required for withdrawal from the parents. Tuition remains due during the notice period.

All fees are **non-refundable** unless otherwise stated.

Tuition Refund Policy

Tuition is **not refunded** for illness, vacation, emergency or weather-related closures, or withdrawal. The **application fee, enrollment/deposit fee, snack fee, and materials fee** are non-refundable.

Discounts

A **5% discount** is available when tuition is paid in full by **June 1st.**

A **2% discount** for Veterans in good status, Police Officers, and Fire Fighters.

A **1% sibling discount** is applied to the second child.

Discounts apply only if tuition is paid by the stated deadlines and are not retroactive.
