Assignment of Proceed of a Verified Life Insurance Policy. (additional fees apply)

Christy-Smith Funeral Homes is willing to accept the assignment of proceeds of a verified Life Insurance Policy for a cost of 5% of the amount assigned to Christy-Smith Funeral Homes. Our acceptance of this type of payment is dependent on the cooperation of the beneficiary and the insurance company. The insurance policy must be given to the funeral director for verification at arrangements. We must have the Insurance Company's complete cooperation in providing information to the beneficiary, amount of Death Benefit available, outstanding loans information, cooperation to claim forms in a timely manner, and their acceptance of our written assignment. The Insurance Company will send the balance of any proceeds directly to the beneficiary after the Insurance Company pays the funeral bill in full from the proceeds of the insurance policy. The purchaser must obtain a certified death certificate for each insurance policy.

Our charge includes funeral counseling, necessary arrangements, recording vital statistics, securing permits, filing and obtaining death certificates and other forms and claims, preparing of necessary notices, and coordination of service plans with parties involved in the final disposition of the deceased. This fee for our basic services and overheads will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding and receiving remains.)	
Embalming (Includes use of preparation room, professional services, equipment and materials)	\$ 895.00
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. The State of Iowa requires embalming if the body is not buried or cremated within 72 hours from the time of death. Our policy requires embalming if there is an open casket during public visitation. (\$350.00 additional charge for autopsy or donor restoration)

Receiving Cremated Remains from Another Funeral Home

This discounted package includes basic services of staff and transportation to the local cemetery (25-mile radius). Beyond 25 miles, mileage is billed at a rate of \$2.00 per mile after 25 miles each way.

Direct Cremation

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of material like heavy fiberboard or composition materials (with or without an outside covering). The containers we provide are corrugated cardboard containers, some with a wood bottom, or any nonmetal casket of your choosing. * Refrigeration of the deceased and/or Custodial Care (Begins 72 hours after death and the funeral home has custody of the deceased, the holding fee is \$85.00 per day until completion of services.) *Deaths in Iowa require a Medical Examiners permit for cremation. (\$75.00 permit fee)

Our charges for direct cremation without ceremony include:

Removal of the remains and transportation to the crematory, basic services of staff, care of remains prior to cremation, and the cremation process.
