## **Friendly Reminders:**

- 1. Please be sure to turn the power on in the unit on or before your move-in day.
- 2. If applicable, please pre-register your dog(s) with PooPrints DNA solution for dog waste here: <a href="https://dnawpr.com/reg/b53yg9">https://dnawpr.com/reg/b53yg9</a> Please reach out within 5 days of your move in date to make an appointment for a swab test for your pet. If no appointment is made you will be FINED.
- 3. You have 30 days to switch the utilities into your name, in the meantime you will be charged the prorated amounts according to usage. If not switched within 1

- month you will be charged an additional \$15 accounting fee. After 3 months the utilities will be disconnected without notice.
- 4. Checklist is to be submitted to I & A Properties within 5 days of move in date and emailed to <u>iandaproperties.is@gmail.com</u>. Any nonconformities found after the fifth day will be assumed to have been caused by the tenant.
- 5. A submission of the Property Checklist does not constitute as a maintenance request. Submit your maintenance request through your tenant portal.
- 6. Rent is due on the 1<sup>st</sup> of every month. If not received by 11:59 pm on the 5<sup>th</sup> day of each month, a \$100 fee will be applied. If still not received by 11:59 pm on the 10<sup>th</sup> an eviction notice will be posted.
- 7. You can conveniently pay online through your Tenant Portal
  - a. eCheck Enter your routing and account number to pay rent directly from your checking or savings account. There is a \$2.49 transaction fee.
  - b. Credit Card Charge your rent to your credit or debit card; earn points or pay over time. All card payments.
  - c. A convenience fee of \$20 will be charged for all non-online payments, including and not limited to cash, check, and money orders.
- 8. Miscellaneous maintenance, such as but not limited to: air filters, light bulbs, pest control etc. are the responsibility of the tenant. The owner is not responsible for handling minor issues.
- 9. If maintenance is dispatched for a false alarm, a \$50 fee will be charged.
