Safeguard American Voter Eligibility (SAVE) Act S. 1383 (Senate) / H.R. 7296 (House)

Passed U.S. House – February 11, 2026 Now Awaiting Senate Action
Restoring Election Integrity

Only American Citizens Vote in Federal Elections.

Easy to Vote • Hard to Cheat

The SAVE America Act builds on the original SAVE Act by adding commonsense safeguards that enjoy overwhelming bipartisan support. It ensures non-citizens cannot register or vote in federal elections while protecting every eligible citizen's right to vote.

KEY PROVISIONS

- **Documentary Proof of U.S. Citizenship Required to Register.** (Amends National Voter Registration Act of 1993) States may not accept or process any federal voter registration application without proof such as: • REAL ID-compliant identification showing U.S. citizenship • Valid U.S. passport • Certified birth certificate + government photo ID • Military ID + U.S. birth record • Naturalization/Citizenship Certificate or American Indian Card (KIC) Clear processes address name changes and limited attestation options with affidavits.
- **Photo ID Required to Cast a Ballot.** (Amends Help America Vote Act of 2002) • In-person: Valid physical photo ID (driver's license, passport, military/tribal ID, etc.) • Mail/absentee: Copy of photo ID or last-4 SSN + affidavit Provisional ballots available with follow-up; free public copying stations provided. Effective for 2027 federal elections.
- **Mandatory Voter Roll Cleaning.** States must submit rolls to DHS SAVE system to identify and remove non-citizens (with notice and opportunity to cure). Federal agencies must assist within 24 hours. Ongoing maintenance required.

STRONG PUBLIC SUPPORT

Over 80% of Americans – across party lines, racial groups, and battleground states – support requiring proof of citizenship and photo ID to vote (Heritage Action & multiple polls cited by sponsors).

NEXT STEPS

Senate must bring the bill to the floor for real debate and passage so it reaches President Trump's desk.

SAVE AMERICA ACT TALKING POINTS

About the SAVE America Act

- You need ID to buy beer, board a plane, and pick up a prescription. You should need ID to vote for President of the United States. The SAVE America Act makes that the law.
- The SAVE America Act requires proof of American citizenship before registering to vote, and a valid photo ID when showing up to cast a ballot. That is the entirety of the controversy Democrats are manufacturing.
- The SAVE America Act also requires states to clean their voter rolls by cross-referencing them against federal immigration databases. Non-citizens and deceased individuals have no business being on voter rolls, and the SAVE America Act ensures they are removed.

Common Sense Solution

- Election integrity is not a Republican issue or a Democrat issue. It is a foundational American issue. Anyone who believes their vote should count should want only eligible voters casting ballots.
- The SAVE America Act does not ask for anything unusual. Most democracies around the world require ID to vote. The SAVE America Act simply aligns the United States with that commonsense standard.
- Public confidence in elections is not optional in a self-governing republic. The SAVE America Act is the vehicle for restoring that confidence, and the Senate must act.
- 85% of Americans support the SAVE America Act. That includes Democrats, Independents, and every racial group polled.
- President Trump called the SAVE America Act his "No. 1 priority" and it received a standing ovation at the State of the Union address.



SAVE AMERICA ACT TALKING POINTS

Common Sense Solution (Cont.)

- The House has passed the SAVE America Act. More than 48 Senators have co-sponsored it. The only obstacle is Senate Democrats who do not want to be on camera explaining their opposition to commonsense election security.
- The SAVE America Act is the democrat's worst nightmare. Chuck Schumer called the SAVE America Act "pernicious" because it would remove "millions" from voter rolls. Those millions are non-citizens. His own words are the strongest advertisement for passage.

The Political State of Play

- Senate Democrats have been blocking the SAVE America Act through a procedural filibuster that requires no effort and no accountability. Senator Lee wants to force them into a talking filibuster on the Senate floor to publicly defend their position and wait out their obstruction.
- Senate Majority Leader Thune has committed to bringing the SAVE America Act to the floor for an extended debate. Under this approach, Democrats will be publicly arguing against voter ID and proof of citizenship for a bill that nine out of ten Americans support. The American people deserve to hear that debate in full.
- More than 80 organizations and 700 state legislators have sent letters to Senate leadership demanding a real vote on the SAVE America Act. That grassroots pressure is working, and it cannot stop now.
