"If I hadn't come to Paxton, I'd probably be in jail by now."

Before moving to Paxton Street Home, Doris's life felt out of control. "I had so much anger," she recalls, "and my outbursts scared people away." In her first months at Paxton, Doris's temper flared daily. "I threw things and yelled at everyone; I even broke my phone." Each episode left Doris feeling worse. "I was worried I might hurt someone," she admits. "It made me mad at myself."

Paxton staff spent countless hours working with Doris, calming her down and coaching her toward healthier choices. Slowly, Doris realized that Paxton staff were determined to see the best in her. "The people who work here — they were kind to me," remembers Doris. "It made me want to be better."

Eventually, her neighbors noticed a difference. First, it was her hair. After letting staff comb and braid her tangled locks, Doris took more pride in her appearance, bathing regularly and wearing clean clothes. She began smiling more and yelling less. She started going to staff for advice and began mental health counseling. With this support, Doris learned tools to control her anger, dramatically reducing the frequency of her emotional outbursts.

Last year, Doris got a job with Paxton Solutions, working in the dish room at Paxton Street Home. "I hadn't worked in decades," recalls Doris. "I sometimes felt overwhelmed, but the staff would help me." Having a part-time job has helped Doris feel better about herself and stay focused. "I feel happy me when I work. It keeps me out of trouble."

Today, Doris is proud of the person she's become. "My life got changed... I'm making better decisions about where to go and who to hang out with." Most importantly, Doris feels like she finally has friends. "I care about other people now. I talk to other residents to see if they need help. Some call me 'mom'. It makes me happy to have friends." Without Paxton, Doris doesn't think any of this would have been possible. "My life wouldn't be like this," she says decisively. "Paxton has helped me a lot. I feel like my life is under control now."

YEAR TWO OF PAXTON'S STRATEGIC PLAN

Organizational Growth

We praise God for our faithful donors who have answered the call to increase operational giving by 10% this fiscal year. In addition to connecting with new churches, organizations, and other potential partners, **Paxton's leadership approved and initiated the realignment of staff responsibilities** to equip our organization for future growth. We have entered FY 2025-26



with **two new positions to advance our priorities** of building community awareness and expanding independent living opportunities and support to adults in need.

Developing and Utilizing a Comprehensive Care Model

As reported in recent newsletters, we have taken decisive steps towards addressing

the level-of-care challenges faced by our resident population. In our first full year of employing a full-time RN, we saw measurable improvement in the health outcomes of our most medically complex residents, including a **34% decrease in total ER visits.** We likewise continued to strengthen our **partnerships with UPMC and Ponessa Behavioral Health** to bring high-quality, collaborative care right to our residents' doorstep. Through our innovative **Medication Mailboxes** initiative, we have reduced the length of staff-administered medication passes while helping residents gain independence and self-esteem.

Financial Stability and Agility

The Inspire *Hope Endowment Fund* has reached \$1.092 million, bringing us within close range of the \$1.25 million target set at the outset of our strategic plan. Our operational reserves have also grown in step with Paxton's expanded 2025–26 budget. While we've reached 85% of our reserve funding goal, we remain focused on closing that gap in the coming year.

Facility revitalization likewise remains a key priority. This year, we completed a major roof repair at Paxton Street Home and secured funding to fully replace the roof in the 2025–26 fiscal year. We also obtained grant support for much-needed repairs across our Community Living properties. These projects are already underway, and we're preparing for a comprehensive facility-needs survey to guide future improvements.

Employer of Choice

Doris's story powerfully illustrates the impact of staff who care for residents day after day with Christ-like love. We remain committed to supporting the employees of Paxton Ministries so they, in turn, can serve our residents well. This year, **the board appointed a standing Human Resources Committee** to oversee issues pertaining to staff wages, compensation, benefits, and other HR matters (formerly decided by the Finance Committee). We **expanded staffing levels** for critical shifts and **adjusted our weekend schedule** to standardize 8-hour (rather than 9.5-hour) workdays. These changes have provided welcome relief to our hardworking staff and promoted a healthier workplace culture where **employees feel better equipped to care for the needs of our residents**.




2024-2025 FINANCIAL REPORT
