**Shopper Shuttle Pilot Program Information:**

Schuyler County Transit is pleased to be able to offer a Shopper Shuttle every Saturday this August, 2025. The Shuttle offers service in Odessa, Montour Falls, and Watkins Glen using an express version our Village Connections Routes. This allows for quicker trips providing more direct access to our most popular bus stops at Tops/CVS Plaza and Walmart. The Shopper Shuttle is made possible with funds provided by the National Aging and Disability Transportation Center (NADTC). The NADTC is administered by Easterseals and USAging, with funding from the Federal Transit Administration (FTA) and guidance provided by the Administration for Community Living.



**Unable to Get to the Bus Stop?**

**Fixed Route Deviation is Available!**

Route deviation of up to 3/4 mile is available to the general public. It is intended for riders who are not physically or mentally able to get to or from the nearest bus stop. **Service must be reserved by at least the business day prior to needed ride by calling Link-Line at (607) 535-3555.**

Schuyler County Transit Shopper Shuttle Operates on Saturdays in August 2025 ONLY, as a Pilot Program.

**Holiday Schedule:**

This route does not operate on the following observed holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.

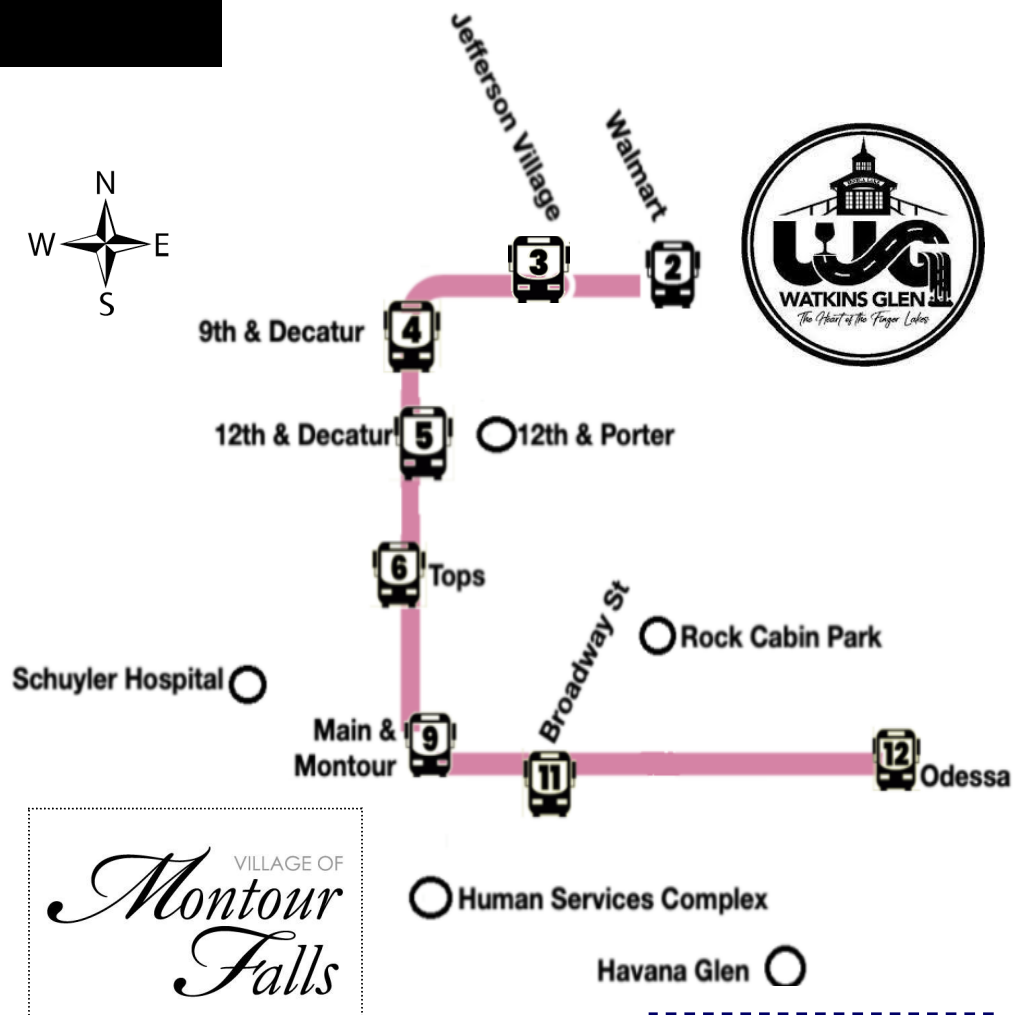
