Fixed Route Deviation:

Route deviation of up to 3/4 mile is available to the general public. It is intended for riders who are not physically or mentally able to get to or from the nearest bus stop. Route deviation is an additional fare for each deviation. **Service should be reserved by at least the business day prior to needed ride**. Call 607-535-3555 for more information.

Monthly Passes:

Monthly passes are only valid for the month which the pass is purchased. Passes must be presented when boarding and remain in possession throughout the trip. The regular pass may be used by bearer's family members.

Persons with Disabilities/Senior Citizens Reduced Fare Passengers with a disability and senior citizens may pay half the cash fare. Passengers must present a Half Fare I.D. card, which can be obtained from the Schuyler County Transit Office by providing proof of eligibility. Proof of having a disability may be verification of SSI, SSD, or Disabled Veteran's Benefits; proof of age may be a Driver's License, other picture I.D. that identifies age, or a Medicare Card. **Monthly Pass rates are only valid on Village Connections and Rural Connections.




