- 11. To review, discuss and take action regarding matters related to the Station 1 construction project including the review and approval of pay applications.
- 12. To review, discuss and take action regarding Department purchase requests related to the provision of emergency services, including maintenance, replacements and improvements of the District's equipment and facilities.
- 13. To review, discuss and take action on approval of expenses related to upcoming training classes.
- 14. To review, discuss and take action regarding repairs to the Station 34 apparatus bay foundation.
- 15. To review, discuss and take action regarding the Station 6 tower project.
- 16. To review, discuss and take action regarding a Request For Proposals related to District Landscaping services.
- 17. To receive a report from the governmental relations committee regarding the 2025 legislative session.
- 18. To review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for June 9, 2025 and discuss any agenda items needed for those meetings.
- 19. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
- 20. To review, discuss and take action regarding District real estate matters.
