Notice is hereby given that **Harris County Emergency Services District No. 16** will hold a public meeting on **April 10, 2026 9:00 a.m.**, at the **District Administrative Building** located at **18606 Stuebner Airline Rd., Klein, Texas 77379**.

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
2. To receive public comment.
3. Review and take action on matters relating to the tax rate cap election on May 2, 2026 including but not limited to authorizing the Board President to appoint members of the Early Voting Ballot Board and Presiding Judges for early voting and election day.
3. Approve the minutes of prior District meetings.
4. To receive reports from the Department.
5. To receive a presentation and demonstration from ZacTax regarding their sales tax software.
6. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments, and payment of the District's bills.
7. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
8. To review, discuss and take action regarding Department purchase requests related to the provision of emergency services, including maintenance, replacements and improvements of the District's equipment and facilities.
9. To review, discuss and take action on approval of expenses related to upcoming training classes.
10. To review, discuss and take action regarding matters related to the Station 1 construction project including the review and approval of pay applications.
11. To review, discuss and take action regarding the Station 6 tower project.
12. To review, discuss and take action regarding adoption, amendment and explanation of District policies, procedures and standard operating guidelines.
13. To review, discuss and take action regarding the District's Deferred Compensation retirement benefits.
14. To review, discuss, and take action regarding a Memorandum of Understanding for a regional partnership to purchase portable radios through the Assistance to Firefighter Grant (AFG) program.
15. To review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for May 11, 2026 and discuss any agenda items needed for those meetings.
16. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
17. To review, discuss and take action regarding District real estate matters.
18. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.

19. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
20. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
21. To meet in Closed Session pursuant to Tax Code §323.3022 to discuss sales tax matters.
22. To meet in Closed Session pursuant to Government Code §551.076 to discuss the deployment or implementation of security personnel or devices, or related security audits.
23. To review, discuss and act on any employment or personnel matters, including District policies, evaluations, benefits, compensation, hiring, retention and evaluation of District employees.
