Notice is hereby given that **Harris County Emergency Services District No. 16** will hold a public meeting on **May 11, 2026 at 9:00 a.m.**, at the **District Administrative Building** located at **18606 Stuebner Airline Rd., Klein, Texas 77379**.

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
2. To receive public comment.
3. To canvass the results of the District's election held on May 2, 2026 and enter such Orders and take such other action as may be necessary on the matter.
4. To review, discuss and take action regarding any other election related matters including but not limited to approval of payment for election workers.
5. To review and discuss matters related to the District's 2025 financial audit.
6. To review, discuss and take action regarding the District's annual contract with EVO (Municipal Information Services) to conduct an update to the 2025 comprehensive review.
3. Approve the minutes of prior District meetings.
7. To receive reports from the Department.
8. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments, and payment of the District's bills.
9. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
10. To designate the Harris County Tax Assessor-Collector's Office to prepare the District's No New Revenue Tax Rate and related tax rate calculations for 2026, and to authorize District counsel to publish the necessary 2026 Tax Rate setting notices.
11. To review, discuss and take action regarding amendments to the District's 2026 budget.
12. To review, discuss and take action regarding the District's contract for internet service with Comcast.
13. To review, discuss and take action regarding Department purchase requests related to the provision of emergency services, including maintenance, replacements and improvements of the District's equipment and facilities.
14. To review, discuss and take action on approval of expenses related to upcoming training classes.
15. To review, discuss and take action regarding matters related to the Station 1 construction project including the review and approval of pay applications.
16. To review, discuss and take action regarding the Gregson tower project.

17. To review, discuss and take action to recognize the annexation of District territory by the City of Tomball, and authorize execution of related resolutions.
18. To review, discuss and take action regarding adoption, amendment and explanation of District policies, procedures and standard operating guidelines.
19. To review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for June 8, 2026 and discuss any agenda items needed for those meetings.
20. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
21. To review, discuss and take action regarding District real estate matters.
22. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
23. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
24. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
25. To meet in Closed Session pursuant to Tax Code §323.3022 to discuss sales tax matters.
26. To meet in Closed Session pursuant to Government Code §551.076 to discuss the deployment or implementation of security personnel or devices, or related security audits.
27. To review, discuss and act on any employment or personnel matters, including District policies, evaluations, benefits, compensation, hiring, retention and evaluation of District employees.
