

PUBLIC MEETING NOTICE
HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 16

Notice is hereby given that **Harris County Emergency Services District No. 16** will hold a public meeting on **July 10, 2026 at 9:00 a.m.**, at the **District Administrative Building** located at **18606 Stuebner Airline Rd., Klein, Texas 77379**.

The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
2. To receive public comment.
3. To receive reports from the Department.
4. To review, discuss and propose the District's 2027 Budget.

This is an item to begin the Budget adoption process for the upcoming FY 2027. The District acknowledges the requirement of Government Code §551.043(c)(2) to prepare a taxpayer impact statement when reviewing and adopting budgets. However, certified values are not yet available and the required no new revenue tax rate calculations are not yet available. Therefore, no Taxpayer Impact Statement is included.
5. To review, discuss and propose the District's 2026 Tax Rate.
6. To schedule a public hearing regarding the District's 2026 tax rate and the date of the meeting to adopt.
7. To review and take action on matters relating to an election to be held on November 3, 2026:
 - a. Approve an Order of Election under Texas Tax Code Section 26.07.
 - b. To review and take action to hold an election jointly with other jurisdictions.
 - c. To review and take action to contract with Harris County Elections Office for election services.
 - d. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election
8. Approve the minutes of prior District meetings.
9. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments, and payment of the District's bills.
10. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
11. To review, discuss and take action regarding District insurance policies including but not limited to increasing policy deductibles with VFIS.
12. To review, discuss and take action regarding Department purchase requests related to the provision of emergency services, including maintenance, replacements and improvements of the District's equipment and facilities.

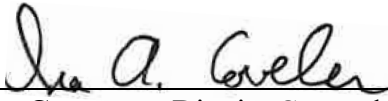
13. To review, discuss and take action regarding shared construction costs and payments made to Texas Emergency Communications Center related to the construction of a new dispatch center.
14. To review discuss and take action on executing any needed debt instruments with the District's lenders.
15. To review, discuss and take action on approval of expenses related to upcoming training classes.
16. To review, discuss and take action regarding matters related to the Station 1 construction project including the review and approval of pay applications.
17. To review, discuss and take action regarding an Interlocal Housing Agreement with HCESD 11.
18. To review, discuss and take action regarding adoption, amendment and explanation of District policies, procedures and standard operating guidelines.
19. To review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for August 10, 2026, and discuss any agenda items needed for those meetings.
20. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
21. To review, discuss and take action regarding District real estate matters.
22. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
23. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
24. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
25. To meet in Closed Session pursuant to Tax Code §323.3022 to discuss sales tax matters.
26. To meet in Closed Session pursuant to Government Code §551.076 to discuss the deployment or implementation of security personnel or devices, or related security audits.
27. To review, discuss and act on any employment or personnel matters, including District policies, evaluations, benefits, compensation, hiring, retention and evaluation of District employees.
