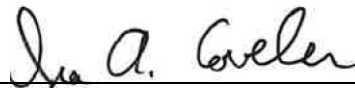
The District will consider and act upon the following matters:

1. Call meeting to order, roll call and establish a quorum.
2. To receive public comment.
3. To receive reports from the Department.
4. Approve the minutes of prior District meetings.
5. Review, discuss, and take action on the District Treasurer's report and take any necessary action regarding the District's investments, and payment of the District's bills.
6. To review, discuss and take action on submittals received from the District Commissioners seeking compensation as permitted by Texas Health & Safety Code §775.038 (a-1).
7. To review, discuss and take action regarding a sales tax audit update from ZacTax.
8. To review, discuss and take action on District 2026 tax setting matters.
9. To review, discuss and take action regarding Department purchase requests related to the provision of emergency services, including maintenance, replacements and improvements of the District's equipment and facilities.
10. To review, discuss and take action regarding a lease agreement for District copier machines.
11. To review, discuss and take action on approval of expenses related to upcoming training classes.
12. To review, discuss and take action regarding matters related to the Station 1 construction project including the review and approval of pay applications.
13. To review, discuss and take action regarding adoption, amendment and explanation of District policies, procedures and standard operating guidelines.
14. To review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for September 14, 2026, and discuss any agenda items needed for those meetings.
15. To review, discuss and take action for the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
16. To review, discuss and take action regarding District real estate matters.
17. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.

18. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
19. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
20. To meet in Closed Session pursuant to Tax Code §323.3022 to discuss sales tax matters.
21. To meet in Closed Session pursuant to Government Code §551.076 to discuss the deployment or implementation of security personnel or devices, or related security audits.
22. To take action on sales tax matters as discussed in closed session.
23. To review, discuss and act on any employment or personnel matters, including District policies, evaluations, benefits, compensation, hiring, retention and evaluation of District employees.
