

NOTICE OF ELECTION

TO: THE QUALIFIED VOTERS OF HARRIS COUNTY, TEXAS, WHO RESIDE IN HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 16:

The Board of Emergency Services Commissioners of HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 16 has issued an Order calling for an election to be held on May 2, 2026 from 7:00 A.M. to 7:00 P.M., at which election all eligible voters residing within the boundaries of HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 16 will be entitled to vote on the following:

TAX RATE -- Texas Health and Safety Code § 775.0745

Proposition A:

THIS IS A TAX INCREASE

FOR

To authorize for Harris County Emergency Services District No. 16 (also known as Klein Fire Department) a maximum ad valorem tax rate not to exceed \$0.10 per \$100 of assessed valuation to fund fire protection and emergency services.

AGAINST

LOCATIONS OF POLLING PLACES: Qualified voters residing in the Harris County Emergency Services District No. 16 may vote in the appropriate polling place locations designated for the election. The consolidated county election precincts and the respective Election Day polling places are described in Attachment 1, below.

EARLY VOTING: Early voting shall be conducted by **Adriane Hutchison**, the Early Voting Clerk, from April 20, 2026, through April 28, 2026. During early voting, a voter may vote at any of the Early Voting polling places as described in Attachment 2, below.
