To ensure that both certifications remain current, please submit your recertification application for both certificates **no less than ninety (90) days prior to the renewal date**. The WOSB Regulation Expiration date denotes the requirement for a full review per the SBA regulation; however, WBENC conducts a full review annually. It is important to obtain recertification prior to your renewal date to remain Active in WBENCLink.

ADDITIONAL STEPS REQUIRED BY SBA

In addition to being granted WOSB certification by WBENC, you must take the following SBA required steps to participate in the WOSB Federal Contracting (Set Aside) Program. Visit https://www.wbenc.org/am-i-eligible to determine if you are eligible:

- 1. Represent status in System for Award Management (SAM) as WOSB*
- 2. Go to https://beta.certify.sba.gov/

a. New Applicants

- i. Scroll down and click on Get Started or Login (for returning applicants)
- ii. Click Create Account
- iii. You will be redirected to SBA Connect site via Login.gov $\,$
- iv. Click Create an account (or login) and follow the prompts to claim your business then submit an application and upload your **WBENC-issued WOSB certificate**.
- v. Once your certification is confirmed, you will receive a formal confirmation from the SBA.

b. Recertification Applicants

- i. Each company must log into their Beta Certify account to annual attestation to the SBA by providing the updated WBENC WOSB Certificate and following the steps for the Attestation.
- ii. This process must be completed within 30 days of the company's anniversary date.

*If not eligible to participate in the set aside program, only Step 1 needs to be completed. Any questions regarding the SBA site should be directed to betacertifyhelp@sba.gov. For program questions, email wosb@sba.gov.
