#### **Definitions**

**Equality** is a question of a fair and equitable **distribution** of **power**, **influence** and **resources** in everyday life and in society as a whole.

A **gender-equal society** safeguards and makes use of every individual's experiences, skills and competence.

#### What is gender analysis?

The term 'gender' refers to the social construction of identity. It can be defined as "'more than biological differences between men and women".

(Ministry of Women's Affairs, New Zealand)


**Gender Analysis** highlights the differences between groups in terms of the distribution of resources, opportunities, limitations and power in a given context.

Performing a gender analysis allows us to correct gender-based inequalities and meet the needs of different groups.


### Gender analysis is the starting point for gender mainstreaming


Gender analysis aims to achieve **equity**, rather than equality.

## Gender and <u>social diversity</u> rather than just gender equality





As a head of the organisation, I am used to listen to my colleagues and I can change my opinion.


I can participate in decision-making processes, but my beliefs hardly ever taken into account.

#### What does "mainstream" mean?




Mainstream - The ideas, attitudes, or activities that are shared by most people and regarded as normal or conventional






