Please print the first page of this form and include it with your film when shipping to us. Cut along the indicated line and attach to your package.

You have two options for completing the form: Fill it out digitally and then print it, or print the blank form and handwrite your information.

1 Fill Out Contact Information.

2 Select Services. Check our website for our price lists. We process 35mm, 120, C41 and B&W films. *Each roll comes with digital scans by default.

TIP!

If your disposable camera has 27 exposures, select '24 exposures'. If it has 39 exposures, select '36 exposures'.

3 Select Shipping Options. Expedited shipping will be calculated based on location. **If you select "Pick-up in-store", your negatives will be available for collection once your order is ready. Negatives not collected within 30 days will be discarded.

4 Add Special Instructions. If you require a non-film developing service (ie Video Transfer, Reprints, Print to Print, Slides, Scanning Negatives), indicate your request in this section.
