Contact Brittany at least two (2) weeks before your trial. If your case settles or if you would like to continue your trial, please e-mail Brittany.

\*\*\*\*\*Failure to follow the procedures could result in your losing your trial date. There is also the possibility of there not being a jury for your trial; therefore, please follow these directions.

The addition of a second Judge has allowed us to add two civil-only terms for the year in February and December. These terms will allow Civil trials to be set as first up trials. If the date is highlighted yellow, that means the date falls within Judge Reed's civil term, and the case will be first-up on the trial calendar. Any other civil trial date is subject to change due to our criminal calendar unless Judge Reed agrees to a special setting.

Jury instructions are due at least three (3) days prior to trial. If the trial is a bench trial, Judge may require a trial brief. The Court will contact attorneys to prepare trial briefs if needed.

All motions need to be heard prior to trial. Judge Reed does not require a pre-trial conference, but if you would like to schedule one, please use the civil motion day prior to your trial date. That date can also be used as your hearing date for any motions in limine.
