### **PURPOSE:**

An institution that wishes to establish its eligibility to participate in any HEA program must submit an application to the Secretary of Education for a determination that it qualifies as an eligible institution under this part. If the institution also wishes to be certified to participate in the title IV, HEA programs, it must indicate that intent on the application, and submit all the documentation indicated on the application to enable the Secretary of Education to determine that it satisfies the relevant certification requirements. Upon submitting HVAC Technical Institute's Eligibility and Certification Approval Report the Director needs to review all programs to identify that proper participation was made based on the institution's courses.

An eligible institution must report to the Secretary of Education in a manner prescribed by the Secretary no later than 10 days after the change occurs, of any change in the following but not limited to the name and/or address of a previously reported location, and measurement of program length.

The Chief Executive Officer -Director is responsible for coordinating to the response with the Secretary of Education in regards to any reported changes that affect the institution's eligibility, and the effective date of that response.
