All charges are due and payable at the arrangement conference.

(If choosing this option, a fee may be added to process the claim)

- Insurance policy and beneficiary information must be verified with the insurance company prior to scheduling of services. This cannot normally be accomplished on a weekend/holiday.
- A beneficiary of the policy must be the buyer.
- All cash advance items are due and payable at the arrangement conference. If necessary, a credit card number will be required to pay for any incidentals such as local and out of town newspapers, etc.

Professional Services

Basic Services of Funeral Director & Staff.....\$1900.00

Our charge includes consultation with the family or responsible party, staff and facilities to respond to initial requests for service, coordinating service plans with cemetery, crematory and/or other parties involved in the final disposition of the deceased, securing official documents and necessary registrations, administrative and legal costs, employee benefits, support personnel, insurance, governmental compliance, taxes, and sheltering of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains. The information listed above is just a glimpse at the extent of the services and facilities we offer. Approximately 60 working hours are involved in arranging and preparing for a funeral service.

This translates into a rate of \$31.67 per hour for our labor.

Our fee for the basic services of funeral director and staff includes, but is not limited to:

- Staff response to initial request for service.
- Conducting the arrangement conference.
- Preparation of biographical and statistical data.
- Examination of financial settlement options.
- Preparation and placement of obituary notices.
- Retention and care of remains prior to commencement of post death activities.
- Medical Waste.

The fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving.)

Embalming

(Including use of preparation room and sanitary care)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary. No human remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)

- Use of facilities/equipment and staff for visitation, viewing, gathering, receiving of friends for memories and condolences.

Forwarding Remains To Another Funeral Home

This package charge includes removal of remains to this funeral home, basic services of funeral director and staff, the basic sheltering of remains, embalming, obtaining necessary permits. It does not include a casket or alternative shipping container, the use of facilities and staff for any visitations or ceremony (public or private) prior to forwarding the remains, or any sheltering for days on which no post death activities occur. Nor does it include transferring the remains to the airport or other destination or charges of common carrier, or anything not expressly stated as being provided.

Receiving Of Remains From Another Funeral Home

This package charge includes receiving of remains from another funeral home, the basic sheltering of remains, basic services of funeral director and staff, the obtaining of necessary permits and authorizations, and local transportation to cemetery or crematory (within 10 miles).

This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or cremation, or any sheltering on days on which no post activities occur. Nor does it include transferring the remains from the airport or other source, or the charges of a common carrier, or anything not expressly stated as being provided.
