**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MCCAMMON ESTABLISHING THE  
CITY COUNCIL MEETING SCHEDULE FOR THE CALENDAR YEAR OF 2026**

**WHEREAS**, McCammon City is a duly created and validly existing political subdivision of the State of Idaho under the Constitution and laws of the state of Idaho; and

**WHEREAS**, under Idaho Code, the City Council, the duly elected governing body of the City, is required to meet on a regular basis to discharge the affairs of the City and is required to publish a calendar of the anticipated meeting dates for the ensuing calendar year, that will assist City Council and staff with advance planning and scheduling of City business and give proper notice to the general public; and

**WHEREAS**, pursuant to Idaho Code 74-204, the following calendar is established, notwithstanding the scheduling of additional meetings as required upon proper notice under the Open Meetings Act; and

**WHEREAS**, the City Council pursuant to this Resolution reserves the right to occasionally hold closed sessions before, during or after the open session portion of each regular meeting or as otherwise needed, in accordance with the Act.

**NOW, THEREFORE**, the City Council of the City of McCammon does hereby resolve as follows:

**SECTION 1.** The City Council hereby establishes 7:00 p.m. as the regular meeting time for each regular meeting.

**SECTION 2.** The City Council establishes the following meeting schedule for the Calendar Year of 2026:


**SECTION 3.** All meetings shall be held at 100 Center Street in McCammon, Idaho, unless advertised otherwise in accordance with state law.

**SECTION 4.** the City may, depending on any number of exigencies that may occur during the calendar year, elect to reschedule any meeting; add additional meetings; combine any meeting with another meeting; or to cancel a meeting in its entirety, provided that all notices and requirements are met in accordance with Idaho law.

**SECTION 5.** The City Clerk shall certify to the adoption of this resolution and shall cause a certified resolution to be filed in the Office of the City Clerk.

**BE IT FURTHER RESOLVED** that this Resolution shall be in full force and effect immediately upon its adoption by the McCammon City Council and that any and all resolutions or parts of resolutions in conflict with this Resolution shall be, and they, to the extent of such conflict are, hereby repealed.
