# **Registration form Circusschool Pretpiste**

By handing in this form you grant permission during the registration period to:

- Stichting Circusschool Pretpiste to send instructions for direct debit to your bank to debit your account for the tuition fee in two annual installments and
- Your bank to to continuously debit the tuition fees from your account in accordance with the instructions from Stichting Circusschool Pretpiste, Amstelveen. If you do not agree with this debit, you can have it reversed. To do this, contact your bank within eight weeks of debiting. Ask your bank for the conditions.

#### **General conditions**

## Clause 1: Registration

A new participant can take one trial lesson. By handing in this registration form filled correctly you register your child for the stipulated class and you commit yourself to payment until cancel notice. Our general notice period is 3 months, or, July 1 for next school season.

Please inform the trainer in case your child no longer can or wishes to take part in the classes.

#### Clause 2: Payment

Payment of the tuition fee takes place through a direct debit authorization into Pretpiste account nr NL34 TRIO 0197 8773 89.

#### **Clause 3: Cancellation of classes**

In case of illness or impediment of a trainer Pretpiste will try to arrange for another trainer.

#### Clause 4: Safety

The teacher organizes the lessons in the safest way possible. Parents are aware that participation entails risk.

Unless culpable acts or omissions by Pretpiste, Pretpiste is not liable for damage resulting from an accident during activities. Any treatment after accidents is at your own risk or that of the health insurer of the participant.

If a participant bears extra risk due to personal circumstances (stress, injury or sickness), please report this to the teacher!

Sportwear applies; gymnastic shoes with non-slip sole; please dress long hair in tail or bun.

# Clause 5: Food and drinks

Please note food nor drinks is allowed in class. Water is.

# Clause 6: Photo and film

During public Pretpiste activities photo or film may be taken. In case you wish your child is not recorded please inform the trainers.

If you make pictures of trainings or closed performances, you may share them with other parents; but do not publish them om social media.

Pretpiste has a safety and privacy policy. It is published on the website, but only in Dutch.

## Clause 7: Liability

Pretpiste is not liable for loss, theft or damage to clothing and / or other personal belongings. We advise participants to leave valuables at home.

For damage caused by a participant as a result of improper use, we may hold the parents liable.
