

Terms and Conditions

Heart-healthy Neighbourhood Action Labs – Project Funding 2027

These terms govern your application submitted to the National Heart Foundation of Australia National Heart Foundation of Australia ABN 98 008 419 761 (**Heart Foundation**) of Level 9, 565 Bourke Street, Melbourne VIC 3000.

By applying, you (**Applicant**) acknowledge and agree to these terms.

1. Application Process
 - 1.1. Applications open on Mon 1 March and close at 5:00pm AEST on Thurs 25 March 2027.
 - 1.2. Applications must be submitted using the form and, in the manner, specified by the Heart Foundation.
 - 1.3. Applications that are incomplete, late, inaccurate, misleading or not submitted in accordance with the stated requirements may not be considered.
 - 1.4. The Heart Foundation may amend, suspend or cancel the application process, assessment process or funding opportunity at any time, subject to applicable law.
2. Eligibility
 - 2.1. Applications are open to individuals, businesses or organisations in Somerset Tasmania and XXX Western Australia and XXX Victoria.
 - 2.2. Individual Applicants must be aged 18 years or over.
 - 2.3. Applicants must be eligible to receive the funding and must have the capacity, authority and resources to deliver the proposed project within the stated timeframe.
 - 2.4. An Applicant may submit more than one application, up to a maximum of three applications.
3. Funding
 - 3.1. Applicants may only request funding between \$500 and \$7,000.
 - 3.2. There is a total funding pool across all three council regions of up to \$21,000.
 - 3.3. Applicants are encouraged to engage with the relevant local council about the need for any potential approvals before applying.
 - 3.4. Funding will not be awarded unless the relevant local council has agreed to the project proceeding either as part of the application or during the assessment process.
 - 3.5. Funding must be used only for the approved project. Funds must be spent, and the initiative must be completed, by 17 December 2027.
4. Assessment criteria
 - 4.1. Applications will be assessed by representatives of the Heart Foundation in its sole discretion.
 - 4.2. The Heart Foundation will consult with third parties, such as local council employees, to assist in the judgement of applications.
 - 4.3. Assessment will include alignment with the heart-healthy neighbourhood objectives, council benefit, community benefit, feasibility, value for money, council support, risk, timing and ability to meet reporting requirements.
5. No guarantee
 - 5.1. Submission of an application does not guarantee funding.
 - 5.2. The Heart Foundation may approve all, part or none of the requested funding amount, accept, reject, shortlist, request further information or impose conditions on any application at its discretion.
 - 5.3. Assessment decisions are final and no correspondence will be entered into.
 - 5.4. Successful Applicants will be required to enter into a written agreement with the Heart Foundation before any funding is provided. The agreement will include legally binding obligations in relation to use of funds, reporting, publicity, privacy, insurance, compliance with laws and any other requirements required by the Heart Foundation.

- 5.5. Any example grant agreement provided during the application process is for reference only and does not constitute an offer or create any binding obligation. Applicants must not rely on it as the final form of agreement. The Heart Foundation may amend, replace, add to or remove any terms before execution, and the final grant agreement will be the agreement executed by the parties.
6. Confidentiality
 - 6.1. The Applicant must keep confidential and must not use or disclose any confidential information of the Heart Foundation except as strictly necessary for the purpose of preparing an application or delivering an approved project, or as required by law.
 - 6.2. Confidential information includes any non-public information disclosed by or on behalf of the Heart Foundation, whether before or after submission of an application, including information about the funding opportunity, assessment process, project requirements, operations, strategies, materials, documents, data and other information identified as confidential or which ought reasonably to be understood as confidential.
7. Conflicts of interest
 - 7.1. Applicants must disclose any actual, potential or perceived conflict of interest that may affect the application, assessment process or project delivery.
8. Privacy
 - 8.1. The Applicant agrees to comply with the *Privacy Act 1988* (Cth).
 - 8.2. The Applicant warrants that any personal information included in the application has been collected lawfully and that all necessary consents have been obtained for that information to be provided to the Heart Foundation.
 - 8.3. By applying, the Applicant acknowledges that they have read and accept the Heart Foundation's Privacy Collection Notice.

Privacy Collection Notice
