Water Slide Naming Contest – Official Rules

1. Contest Overview

The Water Slide Naming Contest invites the public to submit a creative and original name for one of our three new water slides at the Farmington Water Park. One winning entry for each slide will be selected and used as the official name of the slide.

2. Eligibility

- The contest is open to residents of Farmington, Missouri.
- Participants must be at least 48” tall to enter.
- Winners must be able to attend opening day at the Farmington Water Park on Saturday, May 23, 2026, and arrive at 10:30am.

3. Entry Period

- The contest begins on Friday, May 1 and ends on Friday, May 15.
- Entries submitted after the deadline will not be considered.

4. How to Enter

- Participants may submit a name for each slide. However, each person is eligible to win only once.
- Complete the official entry form at the Farmington Civic Center front desk during normal operating hours **OR** mail an entry form to the Farmington Civic Center, Two Black Knight Drive, Farmington, MO 63640.

Water Slide Naming Contest

Each entry must include:

- Color of the slide you are naming.
- Proposed slide name.
- Participant's name, age and height.
- Contact information (email or phone number).
- Parent/guardian consent if participant is under 18.

5. Naming Guidelines

Submitted names must:

- Be family-friendly and appropriate for all ages.
- Not include copyrighted, trademarked, or brand names.

Entries not meeting these guidelines will be disqualified.

Other helpful hints:

- Try to incorporate the color of the slide in the name.
- Try to keep names to three words or less.

Entries not meeting these guidelines will still be considered.

6. Judging & Selection

- All qualifying entries will be reviewed by a Parks and Recreation selection committee.
- The committee may consider creativity, originality, relevance to the slide, and public appeal.
- If multiple entries submit the same name, the earliest submission will be considered.
- The committee reserves the right to modify the winning name slightly for clarity, consistency, or branding purposes.

7. Winner Notification & Prize

- The winner will be notified by the contact information provided.
- The winner will be required to attend opening day at the Farmington Water Park and will be the first one down the slide they named.

Water Slide Naming Contest

- The winning name will be announced publicly and displayed at the water slide.
- The prize may include:
 - Complimentary entry for winner and one guest on opening day.
 - A season pass.
 - A swag bag with promotional items.

Prizes are non-transferable and have no cash value.

8. Rights & Use

By submitting an entry, participants grant the City of Farmington the right to use, display, reproduce, and modify the submitted name for promotional, marketing, and operational purposes without additional compensation.

9. General Conditions

- The sponsor reserves the right to cancel, suspend, or modify the contest if necessary.
- Decisions of the selection committee are final.
- Participation constitutes agreement to these official rules.
