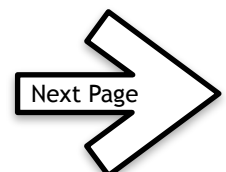

****For trailers older than 25 years - we cannot title your trailer, BUT WE CAN REGISTER IT without a title from another state.**

- Copy of title in your name or transferred to you
- Registration in your name or transferred to you
- Bill of sale or invoice

****For trailers 25 years old or newer and weighing 3001 lbs. or more (empty), you must provide one of the following:**

- Copy of the title - if already in your name (no need to re-title)
- For a trailer transferred to you: **original** title, proof of ownership, and Power of Attorney form Notarized.
- For a new trailer: **original** certificate of origin, invoice or bill of sale, and Power of Attorney form Notarized.



MAINE SALES TAX

If you are registering under a personal name and have not titled, registered, or paid Sales Tax in your state, you will be required to pay Maine State sales tax of 5.5% on the trailer(s) purchase price. If you have previously paid sales tax, we need **PROOF** of paying sales tax. *If your state charges less than 5.5%, you will be charged the difference.*

If registering under a company name, we must have an EIN #.

INTERSTATE COMMERCE

The term “interstate commerce” means trade, commerce, transportation, or communication among several States, or between any foreign country and any State. If you are considered interstate commerce, you most likely have a DOT # and Motor Carrier #, please provide it on our form. If you’re not sure, visit <https://safer.fmcsa.dot.gov/>
