

WEISER CITY ORDINANCE NO. #1276

AN ORDINANCE OF THE CITY OF WEISER, WASHINGTON COUNTY, IDAHO, AMENDING TITLE 1, ADMINISTRATION, WEISER CITY CODE, CHAPTER 7, CITY COUNCIL, SECTION 1-7-3; MEETINGS; SUBSECTION A; PROVIDING FOR THE REMOVAL OF ROBERT'S RULES OF ORDER FOR CITY COUNCIL MEETING PROCEDURES; PROVIDING FOR SEVERABILITY; AND PROVIDING THAT THIS ORDINANCE BE EFFECTIVE UPON ITS PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WEISER, IDAHO, THAT WEISER CITY CODE TITLE 1, CHAPTER 7, SECTION 1-7-3, SUBSECTION A, BE AMENDED TO READ IN ITS ENTIRETY AS FOLLOWS:

SECTION 1: That Title 1, Chapter 7, Section 1-7-3, Subsection A, Weiser City Code is hereby amended to read in its entirety as follows:

“A. The council shall hold regular sessions in the council chambers on the second Monday of each month at the hour seven o'clock of (7:00) P.M. ~~All meetings shall be conducted under the latest edition of "Robert's Rules Of Order", and a copy thereof shall be maintained by the clerk at all times.~~”

SECTION 2: All previous ordinances, resolutions, order, or parts thereof, in conflict herewith are hereby repealed, rescinded and annulled.

SECTION 3: If any part of this ordinance shall be held unconstitutional or void, such part shall be deemed severable, and its invalidity shall not affect the remaining parts of this ordinance.

SECTION 4: The City Clerk is instructed to immediately forward this ordinance to the codifier of the official municipal code for proper revision of the code.

SECTION 5: This ordinance, or a summary thereof in compliance with Section 50-901A, Idaho Code, shall be published once in the official newspaper of the City and shall take effect and be in force upon its passage, approval, and publication.
