**INSTITUTE CANAL PUMP REBATE – Action Item. 7:12:25 PM**

Mike then gave a brief explanation about the special Bonneville Power rebate program limited to pumps and how it is administered including the incentive program that the city receives. This particular process would require Council approval to front the guaranteed rebate money of \$11,750.00 or up to \$12,000.00. Mike further explained that it is the timing of when we receive reimbursement more than the amount of the rebate. Discussion continued.

**CONSIDER SOLAR FARM FEASIBILITY STUDY – Action Item. 7:31:42 PM**

Mike Campbell, this is the scope and budget for the cost of doing a feasibility study for a 5-Megawatt (MW) Solar Farm probably split over two sites, one on each feeder. Mike then reviewed what would be included in the study adding that we budgeted \$150,000.00 to do this study. Discussion about costs followed, including size of property needed, personnel and training it would require to maintain the system. ROI and the reliability issue of solar power were discussed, advantages and concerns were noted. The next discussion was about where we sit right now with our Bonneville contract allotment. Mike broke down our yearly average and how our high usage months affect not only our cost, but how our high use months can also affect the substation. Mike explained that any time we go over 7 MW's we pay market value and currently it is still less expensive to stay at Tier-1 and pay market value when we exceed 7 MW's than to go Tier-2 year-round. Mike added that tariffs just went up so our transmission cost just went up. We will see about a 7% cost increase across the board and maybe more at market. Transmission and infrastructure costs have had big increases, in the past four years Bonneville has raised our rates 25 – 30% but we have not increased our rates. Making power in-house would take away from the upper end power we purchase. Wind and hydropower options were discussed. Market value power cost was discussed. The question of turning our elect power system over to Idaho Power was presented. Mayor Hibberd, with our current Electric Department's reserves, I think the feasibility study cost is worth checking this out. After more discussion there were still concerns about moving forward with the solar farm feasibility study. Discussion about what makes solar unreliable followed. Discussion about rate studies followed. This study will show us what rates should be with and without the solar. Mike stated that if we want to look at generation at all, this study has to be done. The study would show how much power we should make in a year weather added. Break down maintenance is hard to predict after a few years. Mike explained what 5 MWs could operate. Mike added that if Council has more questions they could e-mail them to him and he would forward them to the engineer and have the answers at the next meeting.

**RESOLUTION #705 SMALL URBAN GRANT TO FINISH EAST COMMERCIAL FROM EAST 3<sup>RD</sup> TO EAST 6<sup>TH</sup> – Action Item. 8:06:25 PM**

Mike Campbell, the grant we used to do the first half of East Commercial has expired. The next path forward is through small urban grants which while they have a much higher cap, they also require match money. If we do this grant it has to be in by January 1st. If we get the grant that gets our name on a list, and you move up the list year to year, so it would be three to five years before build. This would give us time to save \$220,000.00 in match money and give us time to work on design. Mike noted that it has already been concept engineered. Discussion followed concerning the match money, engineering costs and replacing the Monroe Creek culvert. Clerk McDaniel added that this resolution is of the City of Weiser, Idaho supporting the project identification submittal for the construction of Commercial Street Reconstruction Phase 2.
