#### ACCEPT KIRK FOLKE 2024 AUDIT REPORT – Action Item. 7:18:13 PM

7:18:30 PM - Kirk Folke, Quest CPAs addressed the Mayor and Council to review the 2024 City Audit Report. The audit went very well, your staff did a great job of having the books and records in good shape and getting them to us to perform a successful audit. Mr. Folke explained and reviewed the two reports from them as our auditors to us the city. The Independent Auditor's Report located on pages 1-3 and the Independent Auditor's Report on Internal Control Over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements Performed in Accordance With Government Auditing Standards Report on pages 40-41. If there were any findings, we would report those here, we would go over those and you as a council would take action.

<u>7:21:00 PM</u> – Review of the Large Governmental Funds: the General Fund, the Street Fund, the Library Fund and the Capital Maintenance Fund on page 9. Mr. Folke reviewed the financial reports for each of these funds stating that the city had a very positive year. They worked hard and stayed within the budget and for the most part have had surpluses across the board. Mr. Folke pointed out the large Investment Return in the General Fund, noting we cannot count on that every year.

#### **Ending Fund Balances:**

General Fund: \$4,193,117.00 14-month reserve.

Street Fund: \$2,536,626.00 Good.

Library Fund: \$432,627.00 Strong, about 2-year reserve. Capital Maintenance: \$1,196,232.00 Almost no activity last year.

Tort Fund: \$109,855.00 For about a 7-month reserve.

The Tort Fund had an intentional decrease of \$53,766.00 to reach a goal of a 6-month reserve.

Airport Fund: \$281,298.00 Very strong reserve.

The Airport reserve is not just an operational reserve, a lot of it is for capital projects and grants and things like that.
