Eric Striker, Striker Surveying, 2074 Shelley Dr, Payette ID. The one lot will be 1.47 acres the remaining fifty-four acres will remain in agricultural production. Mr. Striker verified the access point from Hwy 95 adding that the 16-foot driveway had to cross Monroe Creek at one point. The house will have an individual water well and will utilize a septic system for sewage disposal. The septic system has already been approved by Southwest District Health. Discussion followed about the 16-foot driveway. More discussion followed, Clerk McDaniel reminded Council that this 1.47 acres was rezoned, Mr. Striker added that it was rezoned to A2 Transitional.

PUBLIC HEARING ROBERTS CONDITIONAL USE FOR TOWNHOUSES.

Clerk McDaniel read the Public Hearing Notice into record. Mr. Roberts gave Council a set of plans, pictures of

OPENING COMMENTS: 7:28:45 PM

Brent Roberts, 1423 Larson Rd, Weiser ID. Mr. Larsen gave Council google earth pictures of the lot, they had set of plans and realistic photo drawings of the townhouses. Their plan is to build two five-unit townhouse buildings on the lot. They want to add affordable diversity to the housing market available in Weiser. Mr. Roberts gave details about the townhouses including square footage, and the interior and exterior design plans. Mr. Larsen explained the townhomes would be individually owned, not rentals. Mr. Roberts then gave the pros and issues for their plans including the need to change the zoning and get a setback variance. There was discussion clarifying just what Council was deciding tonight. The Conditional Use for townhouses is the only item before Council tonight. Mr. Roberts added that City P&Z recommended approval of the conditional use pending Council approval. Discussion then turned to why they want to build townhouses and not the allowed duplexes.

7:45:09 PM – Lynette Robert, 1423 Larson Rd, Weiser ID. Mrs. Roberts added that with this lot and property you already have the County, commercial property and a trailer park on E. 12th right behind it, all in the same block. Discussion continued as to why the townhomes would be more appropriate than a duplex.

7:48:47 PM – Malia Bumgarner, 830 Jonathan Rd, Weiser ID. As a Realtor, in Weiser it is really hard to sell a duplex. The five-plex's where you can sell individual units is fabulous and with the renderings of the proposed units, it will help increase the property values of the entire neighborhood.

ROBERTS CONDITIONAL USE FOR TOWNHOUSES – Action Item. 7:59:35 PM

Larry Hogg, we received a lot of information from the applicant, but the only decision we have to consider is whether instead of duplexes or a single-family home they can have townhouses. Larry then talked about the items that were brought up during the Public Hearing by those who spoke against the project, water usage, increased traffic to the area, and safety. Larry feels that the applicants met the criteria for their B-1 zoning being unique and recommends approval of their request. Katie von Brethorst added her recommendation to approve the request. Clerk McDaniel corrected her previous comment; there will not be a preliminary plat process as the property has already been subdivided, they will just come in for design. Discussion about the Design Review Committee's part in the process followed. Marg Chipman agrees with the P&Z Commission's decision to approve this conditional use. Sterling Blackwell noted that their recommendation included with approval by the Design Review Committee. More discussion followed.

The money for the tanks is in the FY2026 budget, so it will be available on October 1st. I would like approval to order them now because it will take two and a half to three months to receive the tanks. Ordering them now will hopefully get them here in November 2025.
