



LYON COUNTY SHERIFF'S OFFICE MEDIA RELEASE

- On Sunday, May 24, 2026, around 8:46pm, Deputy Bobby Beeler conducted a traffic stop, on a Kia Soul, on KY 93 South. The driver was identified as Amber L. Blick (27) of Princeton. She was charged with One Headlamp, Operating on Suspended or Revoked Operator's License, and Possession of Marijuana. She was cited to a June court date in Lyon District Court.
- On Sunday, May 24, 2026, around 11:24pm, the Lyon County Sheriff's Office responded to a disturbance complaint at a Kuttawa business. Eddyville Police Department was called to assist also as the reported disturbance involved multiple persons. Deputy Bobby Beeler and an Eddyville Police Officer detained four persons. Deputy Beeler charged Joseph D. Nonwiler (28) of Owensboro with Alcohol Intoxication in a Public Place-1st or 2nd Offense and Disorderly Conduct-2nd Degree. Nonwiler was lodged in the Crittenden County Detention Center. Deputy Beeler also charged Tanner McFadden (19) of Owensboro with Person 18-20 Possessing, Purchasing, Attempting to Purchase, or Having Another to Purchase Alcohol. McFadden was cited to a June court date in Lyon District Court. The Eddyville Police Department charged two additional persons under 21 years of age for the same offense alcohol-related offenses.
- On Wednesday, May 27, 2026, around 4:18pm, Chief Deputy Sam Adams responded to a two-vehicle collision at the intersection of KY 93 South, KY 293, and KY 1055. His investigation revealed a 2015 Dodge Challenger, driven by Justice Harvey (18) of Eddyville pulled up to the stop sign on KY 1055 at KY 93 before pulling into the path of a North bound 2011 Chevrolet Silverado, driven by Nicholas D. Armer (21) of Eddyville. The vehicles collided in the intersection. No injuries were reported.
- On Thursday, May 28, 2026, around 1:25am, Chief Deputy Sam Adams responded to a two-vehicle collision at a Kuttawa business. His investigation revealed a 2026 Freightliner cab over semi, owned by Royal Trucking of West Point, MS, was parked when another semi was driving through the parking lot of the business and collided with the front of the parked semi on the passenger's

side front bumper. The semi did not stop and continued on. If anyone has information pertaining to this collision, they are asked to contact the Sheriff's Office at 270-388-2311.

- On Friday, May 29, 2026, at 8:55am, Sheriff Brent White was dispatched to a business on KY 293 for a shoplifting complaint. His investigation led to the arrest of Jessica L. Owen (19) of Eddyville. She was charged with Theft by Unlawful Taking or Disposition (shoplifting) Under \$500. Owen was lodged in the Crittenden County Detention Center.
- On Sunday, May 31, 2026 around 12:42am, Deputy Bobby Beeler was dispatched to a Kuttawa business for a reported disturbance. The investigation revealed a verbal altercation turned physical and a female was assaulted at the business. Deputy Beeler's investigation led to the arrest of Michael D. Chamber (27) of Henderson. Chamber was charged with Assault-4th Degree, Alcohol Intoxication in Public Place-1st or 2nd Offense, and Disorderly Conduct-2nd Degree. Chamber was lodged in the Crittenden County Detention Center.
