

LYON COUNTY SHERIFF'S OFFICE MEDIA RELEASE

- On Sunday, August 24, 2025, around 5am, Sheriff Brent White investigated a reported collision in Kuttawa. His investigation revealed a 2020 Volvo VNL driven by Yuvraj Saluja (22) of Ontario, Canada sideswiped a parked and unoccupied 2026 Volvo owned by DRD Express in Bartlett, Illinois. There were no injuries in the collision.
- On Monday, August 25, 2025, around 11:30am, deputies served a Madison
 District Court bench warrant on Sookie Shreve (60) of Irvine. She was charged
 with Failure to Appear in court. Shreve awaits extradition back to Madison
 County.
- On Monday, August 25, 2025, around 1:10pm, Sheriff Brent White met with Katharine R. Stacy (38) of Eddyville after she drove to the Sheriff's Office regarding an unrelated matter being investigated by a deputy who was not onduty at the time. As Sheriff White spoke to Ms. Stacy, he suspected she was under the influence of intoxicating beverages. After completing her business regarding the unrelated investigation, it was confirmed by surveillance video that Stacy was the sole occupant of her vehicle and she drove to the courthouse. She was administered field sobriety tests and subsequently arrested. Sheriff White charged Stacy with DUI-2nd Offense (aggravating circumstance). She was lodged in the Crittenden County Detention Center.
- On Tuesday, August 26, 2025, around 5:50pm, Deputy Bobby Beeler responded to a two-vehicle collision on Center Ridge Road. His investigation determined a 2013 Cadillac SRX, driven by Frank N. Daniel (86), of Madisonville was west bound on Center Ridge when he met an east bound 1995 Chevrolet, driven by Timothy D. Johnson (67) of Eddyville. The Daniel vehicle failed to maintain his lane of travel, resulting in a sideswipe collision. No injuries were reported in the collision.

- On Tuesday, August 26, 2025, just after 9pm, Deputy Bobby Beeler responded to a single vehicle collision on US 62 West in Kuttawa. His investigation revealed a 2024 Kawasaki EX500 motorcycle, driven by Leslie Combs Waide (56) of Almo was westbound on US 62 when she collided with a deer. Combs Waide was transported, by Lyon County EMS, to Baptist Health in Paducah for injuries sustained in the collision.
- On Wednesday, August 27, 2025, just after 9am, Deputy Bobby Beeler responded to a single vehicle collision on KY 293 at I-24, Exit 45. His investigation revealed a 2025 Kenworth semi, driven by Anthony E. Foster (30) of Brooksville, FL, exited the eastbound off-ramp and was attempting to cross KY 293 and re-enter I-24 east when the driver collided a guardrail causing damage for nearly 50 feet. No injuries were reported in the collision. The KY Dept. of Highways was notified and assisted regarding the damage to the guardrail.
- On Saturday, August 30, 2025, just after 3am, Deputy Shannon Oliver responded to a single vehicle collision complaint on I-24 at the 48.5-mile marker. Upon arrival, the operator of the vehicle had fled the scene but was later identified. The driver sought medical assistance at a Clarksville hospital. Charges are pending against the driver of the 2024 Toyota Tacoma SR5 which was totaled in the collision.
- On Saturday, August 30, 2025, around 10:50am, Chief Deputy Sam Adams responded to a disturbance complaint on Elkhorn Tavern Road. His investigation revealed Jennifer L. Swander (38) of Eddyville engaged in a physical fight with a family member. Swander was arrested and charged with Assault-4th Degree (domestic violence/minor injury). She was lodged in the Crittenden County Detention Center.
- On Saturday, August 30, 2025, around 12:45pm, Chief Deputy Sam Adams responded to a complaint at the Western Kentucky Correctional Complex. Following an investigation at this facility, he arrested Danice M. Hood (29) of Patriot, IN, charging her with Promoting Contraband-1st Degree and Possession of Marijuana. Upon entering the correctional institution, Hood was searched prior to visitation with an inmate, in which a Marijuana cigarette was found in her clothing by Corrections Officers. Hood was later lodged in the Crittenden County Detention Center.

 On Saturday, August 30, 2025, around 10:20pm, Deputy Bobby Beeler stopped a 2019 Chevrolet Silverado on US 62, in Kuttawa, near Lake Barkley Drive. The driver was identified as Parker L. Richardson (21) of Fairfield, IL. Following a roadside investigation and the administration of field sobriety tests, Deputy Beeler arrested Richardson, charging him with DUI-1st Offense. He was later lodged in the Crittenden County Detention Center.
